

# ANNUAL REPORT

OF THE

## VICTORIAN ROWING ASSOCIATION.

---

TO THE MEMBERS.

GENTLEMEN,

Your Committee has pleasure in presenting this evening the Thirty-eighth Annual Report and Balance Sheet. Though unsuccessful in regaining the Australian Eight-oared Championship, your Association and the sport throughout the State maintain a prosperous condition, and the increased interest evinced in regatta racing is apparent on perusal of the statement, printed on page 23, showing the number of events, entries, and oarsmen competing at the various regattas during the past two seasons. The statement referred to discloses that at the regattas for the past season there has been an increase, as compared with the previous season, of 13 events and 69 entries, representing 250 oarsmen. During the season the Murray Rowing Association, and also the Wangaratta, Wahgunyah, Rutherglen, and Corowa Border Clubs have affiliated, and the Melbourne Rowing Club intends to again join your Association. A new association has been formed and affiliated, with a view to promoting sculling handicaps. It will thus be seen that your Association now embraces almost every club in Victoria. The finances, despite heavy expenditure, are still in a sound position, as a glance at the Balance Sheet will show. Your Committee desires to congratulate you on the increased strength and prosperity, and the progress the sport is making.

### OPENING OF THE SEASON.

The season was again officially opened with the Henley Regatta on 25th October, 1913. This excellent aquatic carnival fully maintained its reputation, there being 64 crews and 4 scullers entered, making a total of 424 competitors (including coxswains), representing 32 clubs. This surpasses the previous year's figures, which were a record up to that time. The Committee and Mr. John Lang, the Secretary of the Melbourne Amateur Regatta Association, are congratulated upon the continued success they have achieved.

### AUSTRALIAN EIGHT-OARED RACE.

Lower Yarra, 2nd May, 1914.

After a period of six years, this great event was again rowed over the 2½-mile course on the Lower Yarra, from the 3-mile to the ½-mile mark. The six States of the Commonwealth were represented in what proved to be the finest race yet seen since these races started

in 1878. At the first attempt, there was an unfortunate foul after the crews had gone half-a-mile, and the umpire stopped the race and sent the crews back to their original starting point. The crews all got away well the second time, and after lying in third position till within about 100 yards of the finish, the Tasmanians won a magnificent race by five feet from South Australia, who defeated Western Australia for third place by a canvas only. All three crews deserve great praise for their fine exhibition of rowing. Victoria finished fourth, then New South Wales and Queensland, in the order stated.

Victoria was represented by Messrs. D. Laird (Albert Park), bow; A. Harvey (Mercantile), 2; B. Nolan (Civil Service), 3; R. Jenkin (Albert Park), 4; A. S. M'Gregor (Essendon), 5; H. C. Dishner (University), 6; F. Johnson (Albert Park), 7; H. S. Dickinson (Albert Park), stroke; R. Duncan (Albert Park), cox., with R. Cunningham (Civil Service) as emergency.

The Tasmanian Rowing Association is heartily congratulated on its crew's splendid victory.

The officials for the race were:—Umpire, Mr. G. E. Upward; starter, Mr. J. Donald; judge, Mr. S. Shallard; timekeeper, Mr. E. T. Bradshaw.

During the visitors' sojourn in Melbourne, they were entertained at a Theatre Party by the Henley Regatta Committee, whilst your Committee arranged a Smoke Night and a drag drive to Beaumaris. Your Vice-President (Mr. G. E. Upward) also gave a luncheon at Parliament House to the visiting coaches and managers, whilst the delegates to the Interstate Conference were entertained by your Association at a dinner at Hosié's Cafe. The Right Hon. the Lord Mayor (Alderman D. V. Hennessy) also very kindly gave an official welcome to all the visiting crews.

Your Committee desires to place on record its appreciation of the assistance rendered in entertaining the visitors, and also of the courtesy of the Melbourne Harbour Trust Commissioners in allowing a steamer to follow the race and in issuing invitations to the representatives of other Rowing Associations to view the race from the Harbour Trust launch "Commissioner." Your Committee also wishes to thank Admiral Sir William Cresswell for placing his launch at the disposal of the umpire, and the crew, sculler and coach (Mr. M. G. Scott) for their efforts on behalf of the State. The thanks of your Committee are also tendered to the selectors of the Interstate crew, viz., Messrs. W. Potter, M. G. Scott, J. A. Williams, D. Ross, and E. Kenny.

## AUSTRALIAN AMATEUR SCULLING CHAMPIONSHIP.

Lower Yarra, 2nd May, 1914.

This event was decided over the 2½-mile course from No. 10 wharf to the 3-mile mark in Coode Canal on the same day as the Australian Eight-oared Championship. Three States were represented, and Cecil M'Villy (Tasmania) proved his superiority in a very convincing fashion. L. Davis (Victoria) was second, and E. Thomas (South Australia) third. Mr. M'Villy is heartily congratulated on securing his third victory in this event.

### INTERSTATE CONFERENCE.

The Annual Interstate Conference was held at the Amateur Sports Club Melbourne, on Friday, 1st May, 1914, the Victorian representatives being Messrs. G. E. Upward (Chairman), A. J. Shepherd and E. Kenny.

At the instance of the Western Australian delegates, it was decided that any person disqualified by any of the State Rowing Associations on account of not being financial would be debarred from joining a club affiliated with the Rowing Association of any other State.

The proposal to purchase a speed launch for the use of coaches of Interstate crews was considered, and it was decided to take no further action in the matter.

A proposal was submitted by the Tasmanian delegates that any State failing to send a representative for the Interstate Sculling Race

should lose its turn to have both the Interstate Eight-oared and Sculling races rowed on its own waters. After considerable discussion, the motion, which did not find favour with any of the other delegates, was withdrawn.

It was decided, at the instance of your delegates, that notice of any business to be submitted to any future conference must be given to each Association not later than 1st March.

The Tasmanian delegates submitted a motion that the draft Constitution of the proposed Australian Amateur Rowing Council, as submitted by the N.S.W. Rowing Association at the Hobart Conference in 1910, be again considered, subject to alterations. Only the Tasmanian and Queensland delegates supported the motion, which was lost.

## CHAMPION EIGHT-OARED RACE.

Lower Yarra, 21st March, 1914.

Albert Park, Nagambie, and Civil Service entered for this event, and the first-named club is to be congratulated on securing its sixth consecutive win. Nagambie finished second, after a fine race, being beaten by a length and a quarter. The winning crew consisted of C. W. Croft (bow), D. Laird (2), C. P. Leslie (3), R. Jenkin (4), S. Pedder (5), C. Donald (6), F. Johnson (7), H. S. Dickinson (stroke), and R. Duncan (cox.).

## RULES AND REGULATIONS.

At a Committee Meeting held on the 3rd August, 1914, the following clauses were added to Regatta Regulation No. 19, viz.:—

"7 (a).—Light-weight Maiden Eight-oared Races shall be open to all amateurs weighing 10 stone or under who have never won a Light-weight Maiden Eight-oared Race or an ordinary Maiden, Junior or Senior Race with oars."

"8 (a).—Light-weight Maiden Clinker Four-oared Races shall be open to all amateurs weighing 10 stone or under who have never won a Light-weight Clinker Maiden Four-oared Race or an ordinary Maiden, Junior, or Senior Race with oars."

"10 (a).—Light-weight Maiden Pair-oared Races shall be open to all amateurs weighing 10 stone or under who have never won a Light-weight Maiden Pair-oared Race or an ordinary Maiden, Junior, or Senior Race with oars."

At the same meeting, Regatta Regulation No. 9 was amended by striking out the words "Coxswain and the Captain" in the fourth line. This Regatta Regulation now reads as follows:—

"Every Associated Club shall register its coxswain annually with the Association, and every such application to register a coxswain shall be signed by the Secretary of such Club, and shall be accompanied by a fee of five shillings."

The confirmation of these amendments will be necessary at the Annual Meeting.

## INTERNATIONAL ROWING.

The Committee of the Melbourne Amateur Regatta Association has continued its efforts to get an English crew to visit Australia, but, so far, without success. Invitations were also forwarded to the Harvard University and Winnipeg Rowing Clubs to compete at next Henley, but neither club was able to accept.

At a conference of the Rowing Associations of various countries held at Frankfort (Maine) on 15th March, 1913, an agreement was drawn up for the purpose of governing the rowing contests at future Olympic games. A copy of this agreement was forwarded for consideration of the Rowing Associations of the various States of the Commonwealth, and has been signed by the Committee on behalf of your Association.

Your Committee is at present taking action with a view to entering into an agreement with the Committee of the Henley Royal Regatta, whereby competitors nominated by your Association will be accepted at the great English Regatta.

During the past year an effort was made by the New South Wales Rowing Association, on behalf of the Rowing Associations of the Commonwealth, to induce the Stewards of the Henley Royal Regatta to accept an entry of a combined Australian crew, instead of a club crew, in future. A reply has been received to the effect that the regulations of the Regatta will not permit of the acceptance of entries of combined crews.

**MURRAY ROWING ASSOCIATION AND NEW CLUBS.**

During the past season the Murray Rowing Association again affiliated with your Association. The Rutherglen-Lake, Corowa Border, Wahgunyah, and Wangaratta Clubs have also joined your Association, as a result of the affiliation of the M.R.A.

After a period of 18 years, the Melbourne Amateur Athletic Club and Melbourne Rowing Club has again decided to affiliate. The terms on which the club is affiliating are that 15s. of each member's subscription shall be paid to a special rowing account, and 2s. 6d. for every 30s. in this account shall be paid to your Association. This arrangement to hold good only during such time as the club carries on amateur athletics as well as rowing.

**YARRAWONGA ROWING CLUB.**

Your Committee regrets having to report that the Yarrawonga Club disbanded during the past season.

**ANNUAL REGATTA.**

Upper Yarra, 6th December, 1913.

The Annual Regatta on the Henley course was probably the most successful yet held by your Association, the programme containing the record number of 49 events. The various races were won as follows:—Maiden and Junior Sculls, Yarra Yarra (B. G. T. Kelly); Maiden Pairs, University; Special Maiden Fours, Corio Bay; Maiden Fours, Corio Bay; Maiden Eights, Albert Park; Junior Pairs, Nagambie; Junior Eights, Hawthorn; Senior Sculls, Albert Park (L. Davis); Senior Pairs, Banks; Senior Fours, Albert Park.

Your Committee desires to thank those gentlemen who kindly assisted by carrying out the duties of Judges, Umpires, Starters, etc.

The following public regattas were also held during the season, all of which were very successful, viz.:—

Henley-on-Yarra (25/10/13), Seymour (8/11/13), Nagambie (26/12/13), Colac (1/1/14), Murray Rowing Association, Rutherglen (1/1/14), Upper Yarra (24/1/14), Albert Park (26/1/14), Ballarat (28/2/14), Barwon (7/3/14), Bairnsdale (11/4/14), Sale (13/4/14).

In addition to these regattas, the following races were also held, viz.:—

Banks (14/3/14), won by the State Savings Bank; Warehousemen's (25/4/14), won by D. and W. Murray's crew; Schools' (9/5/14), won by Geelong Grammar School; and the Military Race, for the Army Rowing Association's Cup (16/5/14), won by 58th Infantry.

**UNIVERSITY EIGHT-OARED RACE.**

This event was rowed on the Port Adelaide River on Saturday, 6th June, 1914, and was again won by the Melbourne University crew, Adelaide being second, and Sydney third. The Melbourne

University Boat Club is heartily congratulated on putting up the record of being the first University to secure four consecutive victories in this event. The winning crew comprised—W. J. Hayes (bow), C. S. Wood, E. I. Littlejohn, A. Spowers, J. R. C. Cochrane, R. McC. Abernethy, J. L. Doubleday, H. C. Disher (stroke), J. H. S. Jackson (cox.), Mr. Chas. Donald (coach). Mr. Doubleday is congratulated on being the first oarsman to win four consecutive Australian Inter-University boat races.

### AMATEUR SCULLING ASSOCIATION

#### AFFILIATED WITH THE V.R.A.

During the past season several sculling enthusiasts formed an association to carry on a series of Novice and Handicap Sculling Races. The new body, known as "The Amateur Sculling Association affiliated with the V.R.A." has been created with the approval of your Committee, and, judging by the fillip already given to this branch of the sport, it is confidently anticipated that the class of racing which it is promoting will considerably improve the standard of sculling in Victoria.

### STAGING AND DREDGING OF RIVER.

The question of improving the staging in front of the boat sheds is at present under consideration by the Alexandra Park Committee, which now has control of this portion of the river bank. The Department of Ports and Harbours has kindly undertaken to dredge the river at any point where it has silted up between Punt-road foot-bridge and Princes Bridge. Your Committee tenders its sincere thanks to the Department for its action in this matter, and also to the Melbourne Amateur Regatta Association for contributing towards the cost.

### OBITUARY.

It is with deepest regret that your Committee records the death of Mrs. H. G. Turner, the wife of your esteemed President, to whom the heartfelt sympathy of all oarsmen is extended in his irreparable loss.

### POINTS FOR LIGHT-WEIGHT RACES.

It has been decided that, in future, Light-weight Maiden Pair, Four and Eight-oared Races shall count points in the Junior Premiership. The points allotted will be—1 for a Pair, 2 for a Four, and 4 for an Eight-oared crew.

## WARRNAMBOOL REGATTA.

Sanction has been given for the holding of a regatta at Warrnambool on Boxing Day, open only to the Ballarat, Ballarat City, Wendouree, Barwon, Corio Bay, Colac, and Warrnambool Rowing Clubs. The races will not count points in the Premiership competitions, but will be classifying so far as the status of the winning oarsmen is concerned.

## GENERAL.

During the year the citizens of Melbourne decided to hang a portrait of your President in the National Art Gallery as a token of their appreciation of what he has done in the public interest. Your Committee gladly welcomed the opportunity of co-operating in the movement, and showing that it was not forgetful of the support your Association has always received from Mr. Turner, and the keen interest that he has always evinced in the sport.

The question of contesting all sculling races in best boats was considered during the season, but it was decided not to depart from the present practice of using clinker boats for the Maiden and Junior events.

The new eight-oared boat ordered by your Association was delivered in the early part of the season. It is a fine example of the boat-builders' art, and has given entire satisfaction. The boat has been named after your President, the "Henry G. Turner."

## THANKS.

Your Committee desires to thank all those gentlemen who have assisted by donations, officiating at Championships and Regatta events, or in any other way during the season; also the press for kindly publishing items of interest regarding the sport.

## HON. TREASURER.

Included among the large number of oarsmen who, in response to the call of duty, have joined the Expeditionary Force, is Mr. George I. Stevenson, who has been Honorary Treasurer of your Association for the past five years.

Your Committee cannot allow the fact to pass without recording its appreciation of the services of the retiring Hon. Treasurer. Mr. Stevenson has been a distinct force in the counsels of your Association, and by his energy and ability in his work, and his tactfulness and good humour, has earned a very well-deserved popularity. Your Committee wish Mr. Stevenson and fellow-oarsmen God-speed and a safe return, and, as a slight token of appreciation of Mr. Stevenson's services, he has been presented with a sovereign case prior to his departure.

Mr. Alf. W. Massina (Hon. Secretary Hawthorn Rowing Club) kindly consented to take up the Honorary Treasurer's work until the close of the season, and has also accepted nomination for the ensuing season.
