# ANNUAL REPORT

OF THE

TO THE MEMBERS,

GENTLEMEN,

Submitted herewith for your consideration the Fifty-third Annual Report and Balance Sheet of the Association.

Affiliated Clubs now number 34, with a total membership of 2188. Fourteen Regattas and six Championship events were held during the season, the total number of competitors being 3335. The Melbourne (V.R.A.) Regatta, held on 3rd November, 1928, established a record for number of competitors, with 442 oarsmen competing.

The membership of the Association and number of competitors during the past nine seasons is as follows:—

The above figures represent an increase of 75 competitors in the Maiden ranks, an increase of 31 in the Junior division, and a decrease of 97 in the Senior and Championship events. Last season's figures for Senior competitors was a record for the Association, and in an analysis of regatta figures to show cause for the decline for the season under review, the apparent reason is the dates upon which the Championship Fours and Eights were held. Footscray, in 1927-28, when the Champion Fours were held a fortnight after the regatta, had 30 Senior competitors, whilst for 1928-29, nil. Ballarat, in 1927-28, when the Champion Eights were held a fortnight prior to Ballarat, Ballarat Regatta had 79 Senior competitors; this year, with the Eights held in December, 42 Senior oarsmen competed, a decrease of 37. Barwon Regatta likewise shows a loss in comparison. Other regattas show the usual variations, but not to any appreciable degree.

**AUSTRALIAN AMATEUR ROWING COUNCIL.**

The Fourth Annual Meeting of the Australian Amateur Rowing Council was held at the Commercial Travellers' Association, St. George's Terrace, Perth, on Thursday, 2nd May, 1929. Present: Messrs. R. S. Jeffreys, President (W.A.), E. Kenny (Vic.), O. J. Wood (N.S.W.), R. H. Wallman (S.A.), A. R. Yews (Q'ld), L. McPartland (Tas.). The following office-bearers were appointed:—President, Mr. J. P. Marcus (S.A.); Secretary, Mr. E. Kenny (Vic.); Hon. Auditor, Mr. A. W. Massina; Delegates to Olympic Federation, Messrs. H. G. Alderson and E. Kenny.

Tasmania submitted the following notice of motion:—"That each State be given the privilege of not competing for one race in six, as is now the case, with Western Australia and Queensland, without penalty of losing the turn for its race on its home waters."

Victoria proposed the following amendment on the Tasmanian motion:—"That the races for the King's Cup and the President's Cup be rowed every second year, instead of annually, and that the provisions for Western Australia and Queensland being exempted from visiting Brisbane and Perth respectively be deleted." On a vote being taken both the Tasmanian motion and the Victorian amendment were defeated. In submitting the above amendment, your Committee carefully considered the matter, and was of the opinion that, with the increasing cost and the severe financial drain on Associations in financing Interstate representation annually, it would be advisable to arrive at a solution of the difficulty before the chance of the present system breaking down through force of circumstances.

Tasmanian Non-entry.—Tasmania advised that, owing to the disastrous floods, the State would be prevented from being represented in the Australian Championships, and asked for exemption from the obligation of being represented. It was resolved—"That exemption be granted as a special case in view of the exceptional and unprecedented circumstances, and that Tasmania shall not lose its next turn in the rotation of the race."

**AUSTRALIAN EIGHT-OARED CHAMPIONSHIP  
(King's Cup).**

Western Australia, New South Wales, Victoria and South Australia competed in the classic event rowed on the Swan River, Perth, on 4th May, 1929. Tasmania, owing to unprecedented floods, was granted an exemption from representation. Satisfactory conditions obtained for the race, which resulted in a magnificent victory for New South Wales after a sterling race with Western Australia. Victoria were close up for three-quarters of a mile, but dropped back thereafter. The personnel of the New South Wales crew were:—S. F. Evans, 11st. 2lb. (bow); J. T. Mitchell, 12st. 6lb.; N. I. Wood (coach). Won by three-quarter length; West Australia, second; Victoria, 10 lengths away, third; South Australia, four lengths, fourth. New South Wales, whose crew was composed entirely of members of the Mosman Rowing Club Senior Eight, twice winners of the Grand Challenge at Henley, are warmly congratulated on their success in the King's Cup race.

For the first time the Association permitted the selected State crew to be challenged for the right to represent the State in the Interstate Race. Mr. Cecil McVilly was the sole selector and coach, and chose the following crew:—Bow, V. Barker-Hays (Hawthorn), L. Thompson (Richmond), W. T. Owen (Banks), L. Scully (Richmond), W. C. Howarth (Mercantile), H. F. Yuncken (Banks), J. South (Mercantile); Stroke, B. R. Coningsby (Melbourne); Cox, A. J. King; Emergencies, R. Worland (Melbourne), R. O. Miles (Essendon). The crew was challenged by a combination of Ballarat oarsmen, and the test race was rowed over a  $2\frac{1}{2}$ -mile course on the Lower Yarra on Saturday, 13th April, 1929. The Ballarat combination won by six lengths in 17 minutes 33 1-5 seconds, thereby winning the right to represent the State. Mr. C. McVilly accordingly nominated the Ballarat crew as the State crew, and they proceeded to West Australia as the Victorian representatives. Personnel: Bow, J. W. Andre, 11st. 10lb.; E. P. Wilson; Coach, J. B. Suffren. Mr. Suffren was unable to accompany the crew to the West, and Mr. A. Dawson carried out the duties. Mr. E. Kenny accompanied the crew as Manager.

The Committee, in acknowledging their appreciation of the efforts of the crew, coxswain, coach and manager on behalf of the State, also desire to convey their thanks to the members of the originally selected State crew, coxswain and coach selector, who spent considerable time for the sake of Victorian rowing, and took their defeat in the true oarsman's sporting spirit.

The trip to the West was marked by the renowned hospitality of the West Australians, and the Committee desire to record their special thanks to the following:—Mr. Jas. Child, Honorary Secretary, W.A.R.A., whose organisation deserves the highest commendation; West Australian Rowing Association; Mr. R. S. Jeffreys; Perth civic authorities; West Australian Turf Club; West Australian Trotting Association; Mr. T. Mackie; Mr. W. J. Kirkby; Dr. H. Lyon Johnson; Mr. Frank Shaw; Mr. and Mrs. T. Lalor; and Mr. H. Wise (Ballarat), who accompanied the crew.

### AUSTRALIAN SCULLING CHAMPIONSHIP.

(President's Cup).

New South Wales and Western Australia were the only representatives. The Committee decided that, in view of the expense involved and the calibre of Victorian scullers at the time, representation was not warranted. It is hoped that the activities of the newly-formed Victorian Amateur Sculling Association will result in an improvement of the standard in this branch of the sport. H. R. Pearce (N.S.W.), world's champion, added another championship to his imposing list of victories. K. Langley's (W.A.) performance to be within  $3\frac{1}{2}$  lengths of the champion at the finish was highly creditable. Mr. Pearce is congratulated on his third successive Australian Championship.

### INTERSTATE PUBLIC SERVICE RACE.

For the first time a four-oared race was held between crews representing the New South Wales and Victorian State Public Services. The race was won by Victoria, the crew consisting of:—J. W. O. Neil (bow), A. Malcolm, F. J. Davies, G. K. McLeod (stroke).

## VICTORIAN EIGHT-OARED CHAMPIONSHIP.

The race was rowed downstream over a  $2\frac{1}{2}$ -mile course, commencing at the 42 chain mark, Lower Yarra, and finishing at the 3 mile 2 chain mark, Coode Canal, on Saturday, 8th December, 1928. Ballarat Rowing Club was successful, the crew being:—J. Inglis (bow), E. Panther, J. Russell, E. Elsworth, S. B. McGorm, H. Grace, K. Taylor, H. Inglis (stroke), A. J. King (cox.), W. D. Dawson (coach); Melbourne second, Banks third, Hawthorn forth, Richmond fifth, Mercantile sixth. Won by  $3\frac{1}{2}$  lengths, three-quarter length between second and third.

The distance of the race was reduced to  $2\frac{1}{2}$  miles on account of construction work on the Spencer Street Bridge narrowing the width of the river at that part. The race was rowed downstream for the first time, as it was deemed by the Committee that a better course was obtained. Ballarat are heartily congratulated on their win.

Mercantile Rowing Club—J. A. Greenshields (bow), D. C. Brooke, J. South, C. N. McKay (stroke), M. Green (cox.), J. M. Macfarlane (coach)—won the Four-oared Championship by 2 lengths from Banks; Ballarat third, Hawthorn fourth, Richmond fifth, Melbourne sixth, Barwon seventh. **VICTORIAN ONE MILE SCULLING CHAMPIONSHIP.**

Acting on the representations of the Victorian Amateur Sculling Association, a one mile sculling championship was held for the first time. The race was held at Lake Wendouree, Ballarat, on the same day as the Championship Pairs, Saturday, 2nd February, 1929. S. B. McGorm (Ballarat) won by 1½ lengths from A. H. Cambridge (Bendigo) and E. F. Johnson (Mercantile). Time, 5 minutes 57 seconds.

Mr. McGorm is congratulated on winning the first one mile sculling championship of Victoria. His victory was particularly meritorious, as one hour previously he rowed a hard race and finished a close second in the pair-oared championship event.

The Committee has again decided to include the one mile sculling championship in the fixtures, and the race to count three points in the Senior Premiership.

**VICTORIAN JUNIOR EIGHT-OARED CHAMPIONSHIP.**

The race was rowed on Saturday, 20th April, 1929, over a 2-mile course, commencing at the 2½ mile mark, Coode Canal, and finishing at the 40 chain mark, Lower Yarra. Eight crews competed.

Mercantile Rowing Club (A. Sloss bow, R. Scott, D. Saunders, R. W. Lille, S. S. McKay, J. E. Campbell, I. P. Graham, J. H. Bailey stroke, M. Green cox., J. Sprigg coach) won by two feet from Essendon, with Banks a canvas away third, Albert Park fourth, University fifth, Bendigo sixth, Footscray City seventh, South Melbourne eighth. Time, 12 mins. 25 3-5 secs.

With the increasing number of competitors in junior events and the high standard of rowing it was decided to hold a Junior Eight-oared Championship. Conditions for the race were that entries restricted to one crew from a club, open to all oarsmen eligible to row in junior races, the rule in relation to not more than 50 per cent. of a previously successful junior crew again competing in a similar event not to apply to the junior championship race, the race to count one point per oar towards the Junior Premiership, the distance of the race to be two miles.

The introduction of the Junior Championship Race was an unqualified success, and there could be no better testimony to the judgment of the Committee in including the event in the Championships than the excellent race witnessed in the inaugural contest. For over a mile not one length separated the eight crews, and at the finish a canvas covered the first three crews. The standard of rowing was highly commended by experienced critics of the art of rowing. The race served an excellent purpose in demonstrating that amongst the junior ranks Victoria possesses promising oarsmen capable of fighting out a hard race, and should help as an additional guide to selectors for Interstate purposes.

**PREMIERSHIPS.**

Mercantile Rowing Club won the Senior Premiership with 40 points, and the Junior Premiership was won by Albert Park Rowing Club with 71 points and the record number of 20 wins in regatta races. The Junior Premiership was particularly keenly contested, the Champion Junior Eights, the last race of the season, deciding the issue. Mercantile and Albert Park Rowing Clubs are heartily congratulated on their victories. The points scored in the respective Premierships were as follow:—

That the proposed members of the Interstate crew be free to compete in any regatta until the Eight-oared Championship Race has been decided, but not thereafter in any particular season." It was also decided "That two selectors be appointed, who shall appoint the coach at any time, who will then act as third selector. If the selectors fail to agree on the appointment of a coach, the Executive shall be empowered to appoint the coach." Following on the motion in relation to selectors, eight nominations were received. A preferential ballot was taken at the September meeting, resulting in the appointment of Mr. Geo. Anderson (Hawthorn) and Mr. W. R. B. Todd as the two selectors for the Victorian Interstate crew and sculler for the season 1929-30. The Committee congratulate the selectors on their appointment, and trust that their selection will acquit Victoria with honors in the Interstate contest.

### AFFILIATED CLUBS.

During the season Dimboola, Antwerp and Corowa Rowing Clubs became affiliated with the Association. Dimboola conducted a Regatta during November, 1928, and Ballarat oarsmen who competed voted the fixture first-class. The acquisition of the three Clubs will further strengthen the sport in Victoria.

Yarra Yarra Rowing Club Boathouse and entire fleet was totally destroyed by fire on the 28th January, 1929. Essendon and Hawthorn Rowing Clubs also lost two clinker eights, four clinker fours, three clinker pairs and two sculls in the disastrous fire. The Clubs concerned were covered to an extent by insurance. It is with regret that the Committee record that one of the members of the Yarra Yarra Rowing Club, Mr. Cedric Swallow, sustained fatal burns as a result of the fire. To his relatives the deepest sympathy is extended.

Yarra Yarra Rowing Club members have by their enthusiasm again illustrated the oarsman's love for his Club. By dint of hard labour in the intervening time they have erected a splendid Clubhouse on the old site. Their new quarters are spacious and architecturally an adornment to the river banks. Yarra Yarra members and supporters are heartily congratulated on their achievement, and the best of success for the coming regatta races.

Essendon Rowing Club have enlarged their Clubhouse by the addition of a wing.

In practically every affiliated Club improvements have been made as regards accommodation and catering for the welfare of members. Necessarily such work is expensive, and a perusal of Club balance sheets show that the subscription of members does not in most cases cover the working expenses of the Club. The extra revenue is derived from the activities of social committees. This observation is only made in order that Club members will fully realise, when called upon to assist their Club in the matter of raising funds, they are not being asked to perform a task which members of other Clubs are not required to undertake.

### MELBOURNE METROPOLITAN BOARD OF WORKS.

The work that has been carried out by the Metropolitan Board of Works in connection with the improvement of the river banks in the metropolitan area during the season is extremely satisfactory. As citizens, and from the nature of the sport followed, the Committee may be pardoned in stating that they more fully estimate the invaluable work which has been carried out in the preservation and beautification of the river banks than the majority of other members of the community. The Metropolitan Board of Works is complimented on the improvements made to the banks of the Yarra Yarra and Maribyrnong Rivers.

### MOTOR BOAT.

Considerable use has been made of the motor boat purchased by the Association for coaching purposes for the Interstate crews. It was not possible to obtain the use of a motor boat at Perth for the last Victorian Interstate crew, and the Association boat was shipped to Perth, being used conjointly by Victoria and N.S.W. The Committee has decided that the boat is available for hire to Clubs for coaching purposes, the charge being fixed at 10/- per hour and 5/- for each additional half hour, 15 minutes for preparing the boat for use, and 15 minutes for mooring being included in the time of

hire. The Committee is grateful to Mr. Geo. Hutton, who has undertaken the task of looking after the motor boat and driving the boat for the coach of the Interstate crew. Mr. Hutton has spent innumerable hours of his leisure time in the interest of the Association, and is deserving of the best thanks of members.

#### REGATTA REGULATIONS AND LAWS OF BOAT-RACING.

The Executive has revised the V.R.A. Laws of Boat-racing and Regatta Regulations in conjunction with the Rules of the Australian Amateur Rowing Council, together with necessary amendments thought desirable. The revised Laws and Regatta Regulations will be submitted for approval at the Annual Meeting of the Association.

#### CHAMPIONSHIP COURSES.

During the season the Committee has occupied much time in consideration of the question of the most suitable course to row Championship events. In the deliberations on the subject much useful information was forthcoming from the Melbourne University Boat Club who had made exhaustive inquiries for a suitable place to row the Interstate Universities' Boat Race. It was generally agreed that the Yarra River was ideal for races up to 1½ miles, but even then the increasing number of entries in Championship events presented difficulties; for races over 2 miles or more, owing to the bends in the river, the question of the distance covered by the crews from different stations in the race was debatable, the preponderance of wins from No. 1 Station were points that led members to consider the advisability of endeavouring to obtain a better course. After detailed inquiries it was resolved that the first Championship event for the season 1929-30 be rowed at Lake Colac. Accordingly the event to be rowed at Lake Colac will be the Championship Fours, on Saturday, 14th December, 1929. The Colac Regatta Committee has intimated that every effort will be made to make the fixture an unqualified success, the freight of competitors' boats will be guaranteed. Lake Colac presents the ideal setting for a regatta, capable of accommodating an unlimited number of competitors in a race, a perfectly straight course, and ideal surroundings for spectators to view the race. Being a lake the water is naturally subject to the wind, but statistics supplied to the Committee indicate that the percentage of days upon which the Lake is not suitable for rowing is small. Favoured with a good day, the venture of the Committee in holding the Championship Fours Race at Colac should be highly successful and will undoubtedly create more interest amongst the public than previous Championship Races on the Lower Yarra.

#### RULES.

At the Annual General Meeting on 1st October, 1928, the following additions to Rules and Regatta Regulations were approved:—

Rule.—No motion passed at a meeting of the Committee shall be rescinded unless on four weeks' notice to that effect, and unless the motion for the rescinding be carried by a three-fourths majority of the members present at the meeting.

Rule.—A nomination form for membership to a Club shall be used in accordance with the fifth schedule hereto.

Regatta Regulation.—All courses for qualifying regatta races shall not be less than one mile in length, except with the approval of the Association.

Regatta Regulation.—Championship races shall be open to any class of boat.

## FINANCE.

### Donations Interstate Fund.

Financing of the Interstate crew to compete in the Interstate Eight-oared Championship at Perth was for a time a matter of concern to the Committee. Various capital commitments in the purchase of rowing equipment for the Interstate crew and a motor boat for coaching purposes left practically a negligible balance for the commencement of the season and no reserve for financing the most expensive of the Interstate trips. An appeal was made to the rowing clubs, regatta committees and supporters of the sport. The result was exceedingly gratifying as indicated by the appended list of donors. The sum of £331/9/- was raised, and this, together with the ordinary revenue of the Association, covered the expenses in connection with the Interstate trip. The Committee express their deep appreciation for the generosity of the numerous subscribers named below. No response which the Association has made has been found wanting of support from amongst past or present oarsmen, a further testimony of the splendid spirit of amateurism existent amongst rowing men.

Junior Championship Medals.—It has been decided that the members of the winning crew of the Champion Junior Eights shall be presented with medals similar in design to the Championship medals, with a distinctive shield.

Rule of the River.—Attention has been invited from time to time to the necessity of strict compliance with the rule in relation to the course of boats during training on the Yarra River. Clubs are warned that severe penalties will be inflicted for breaches of the rule of the River Regulations.

Mr. R. R. Sullivan, who had acted as Assistant Honorary Secretary for 18 months, has been forced, through illness, to resign from the position. Mr. Sullivan had rendered valuable service to the Association, and it is hoped that he will speedily recover his normal good health.

Memorial Judge's Box.—It is hoped that by the end of the coming season the Memorial Judge's Box, sanctioned by the Committee to be erected at the finish of the Henley Mile, will be completed.
