RULES

Amend that part of Rule XXXIV relating to Novice Events to read—Novice Events, One point per man for winning crew (in each division where applicable).

REGATTA REGULATIONS AND LAWS OF BOAT RACING

Add-

1 (a) In these regulations, unless inconsistent with the text, a novice rowing race shall include novice rowing races conducted in divisions.

Add 12 (c)

Where the entries received for a novice fours event exceeds 13, then the crews will be divided into two divisions, and points and trophies or trophy orders will be awarded to winning crews in both divisions.

Where the entries received for a novice fours event exceeds 20 then the crews will be divided into three divisions and points and trophies or trophy orders will be awarded to the winning crews in each division.

Where the entries received for a novice fours event exceeds 27 then the crews will be divided into four divisions, and points and trophies and trophy orders will be awarded to the winning crews in each division.

Add 12 (d)

Where the entries received for a novice pairs event exceeds 13, then the crews will be divided into two divisions and points and trophies or trophy orders will be awarded to the winning crews in both divisions.

Where the entries received for a novice pairs event exceeds 20 then the crews will be divided into three divisions and points and trophies or trophy orders will be awarded to the winning crews in each division.

Where the entries received for a novice pairs event exceeds 27 then the crews will be divided into four divisions and points and trophies and trophy orders will be awarded to the winning crews in each division.

(b) Submitted by Mercantile Rowing Club-

Amend Rule XXXIV by deleting the last paragraph:

'Junior or Lightweight . . . in the crew' and substituting therefor:— ''Junior Champion crews and Lightweight Champion Pair-oared crews must

be selected from one club only.

Lightweight Champion Eight-oared and Four-oared crews may be composite crews providing the clubs represented in such composite crews have insufficient lightweight oarsmen available to compete in such Championship. Application to enter a composite Lightweight Champion Eight-oared crew or Four-oared crew shall be made in writing to the Association at least seven days prior to a meeting of the Committee held on a date before the closing of entries for such Championship. The application shall name the oarsmen in the crew and the clubs they are representing and the Secretary of each such club shall sign a statement that the Club has insufficient lightweight oarsmen available to boat a club eight-oared crew or four-cared crew in such Championship.

Premiership points will be awarded according to club representation in a composite Lightweight Champion Eight-oared crew or Four-oared crew.

A composite Lightweight crew which has been granted approval by the Committee to compete in a Championship may compete in that class of boat at qualifying regattas grouped with such Championship and if successful shall be awarded the trophies for such event, but shall not be eligible for premiership points, the points for such regatta races shall be awarded to the first club crew to finish.

(c) Submitted by Footscray City Rowing Club-

RULES

That under Rule XXXV (a) the words, or lightweight senior, be introduced so as to read.

"Clubs which are unable to satisfactorily boat their eligible senior, or light weight senior oarsmen, may with the approval of a three-fourths majority of the members voting at the meeting of the committee, combine to form a composite senior or lightweight senior eight, four, pair or double scull to race in championships and qualifying regattas," . . . etc.

(d) Submitted by Power House Rowing Club-

RULES

Amend Rule XXXIV by inserting after "Novice Events" — "Beginners' Events: One point per man per winning crew."

REGATTA REGULATIONS AND LAWS OF BOAT RACING

Amend Regatta Regulation 2 by adding after sub-clause (w) — "(ww) Beginner Four-oared races shall be open to all members who have not won any race excepting only a Beginner Pair-oared race, who have been members of an affiliated Rowing Club for less than one 12-months season, and who have not represented their school in competition.

Beginner Pair-oared races shall be open to all members who have not won any race, excepting only a Beginner Four-oared race and who have been members of an affiliated Rowing Club for less than one 12-month season, and who have not represented their school in competition."

NINETY-FOURTH ANNUAL REPORT AND BALANCE SHEET OF THE VICTORIAN ROWING ASSOCIATION

To the Members, Victorian Rowing Association. Gentlemen,

Your Committee has pleasure in presenting the Ninety-fourth Annual Report and Accounts covering the 1969-70 rowing season and the year ended 30th June, 1970, respectively.

Probably the most outstanding feature of a very busy and successful season was the continued prominence of Victorian oarsmen in the interstate and international rowing scene.

Earlier in the season a team from Melbourne University made a successful visit to Japan and competed in the All Japan Championships, the results of which are reported later in this report.

The success of the Victorian Eight in retaining the King's Cup, which for the record is the 15th time this State has won the Cup in the 25 times it has been competed for since the Second World War, started quite a series of wins for Victorian club and schoolboy oarsmen. At the National Regatta held at Penrith, New South Wales, in May, Victorian oarsmen won the Australian Championship pair with and pair without, school fours and school eights events.

Melbourne University are to be congratulated for winning three out of the four inter-varsity events at the Championships held in Canberra in June.

On the international scene, the Association was very pleased to learn of the selection of the following members to the Australian eight-oared squad to contest the World Rowing Championships at St. Catharines, Canada, in September: G. Boykett, S. Gillon, D. Douglas and J. Shanasy (Mercantile), P. Guest (Banks), K. Jelbart (Monash University) and G. Godkin (cox).

The Association was delighted on hearing the news that G. Xouris and J. Watt, of the Corio Bay Club, were selected to represent Australia in the coxless pairs event, and that Messrs. D. Boykett and N. F. Wilkinson were appointed coach of the eight and team manager respectively.

Messrs. Xouris and Watt have already left Australia for Europe and America and have competed at Henley Royal Regatta, coming second in the final. The remainder of the team, consisting of the eight and a coxed four from Tasmania, leave on 13th August to compete at the New England Championships at Massachusetts and the N.A.A.O. Championships at Camden, New Jersey.

It is of significance that the eight-oared squad is in effect the first truly composite Australian eight-oared squad for the remaining four members are R. Elleway and W. Hume (South Australia), C. King (Tasmania) and M. Morgan (New South Wales).

The coxed four comprises V. Gibson, R. Free, T. McKay, R. Manton, D. Rattray (cox), and Dr. B. Palmer (coach).

The Association wishes the team success and is confident that they will acquit themselves well and do much to enhance the already fine record established by recent Australian crews.

It is appropriate at this stage to record that the team manager, Mr. Noel Wilkinson, who for so many years has been a loyal and devoted supporter of rowing from club through to international level, was elected a Life Member of the Association at the July meeting of the General Committee.

The State senior and junior premierships were won by Mercantile Rowing Club, and your congratulations are extended to the club.

Barwon Rowing Club won the lightweight and country premierships, a very fitting win to celebrate their Centenary year, and congratulations are extended in regard to both occasions.

The Members of the Australian Rowing Council and its Honorary Secretary, Mr. R. G. Blundstone, O.B.E., again provided guidance and encouragement to ensure that Australian Rowing was promoted to the full. Mr. Norman Cairnes completed his term of office as Victorian delegate to the A.A.R.C. and in accordance with an Association minute, retires. During his six years as delegate, and before that, as Hon. Secretary of the A.A.R.C., Mr. Cairnes has given outstanding service to Australian rowing and has played a major role in enhancing the image of the Council in the eyes of the rowing world. This Association is greatly indebted to Mr. Cairnes for representing Victoria so capably and we offer him our grateful thanks.

Late in the season a fire destroyed the Richmond Rowing Club shed and fleet, but members of the club and other Association clubs have taken action to alleviate some of the immediate needs which have arisen as a result of the fire. The members of Richmond are to be commended for their efforts to date to ensure the rehabilitation of their club.

The year 1970 brought to Victoria the King's Cup and Australian Rowing Championships and the Association wishes to thank all of those members who gave of their time and effort to assist in the running of the regatta and thereby ensure its success.

The Old Oarsmen's Association again gave splendid support to the Association and its executive and members are to be thanked for their assistance, which was always so readily given. This support is in no small way one of the reasons for the success currently being enjoyed by Victorian Rowing.

It is gratifying to note the increase in membership of country clubs and it is to be hoped that it continues.

Significant items of interest which occurred during the season are set out below:

AUSTRALIAN EIGHT-OARED CHAMPIONSHIP (THE KING'S CUP)

The Association was responsible for conducting the 1970 Australian Rowing and Sculling Championships, which were held at Lake Wendouree, Ballarat, on the 2,000 metres Olympic course. Heats and repechages were held on Friday, 3rd April, and final on Saturday, 4th April, 1970.

The committee appointed to organise and conduct the regatta comprised Messrs. R. R. Aitken (Chairman), N. W. Cairnes, R. B. Duncan, R. G. Harding, T. Rodda, P. J. Thomson (Secretary), and N. F. Wilkinson, of the Victorian Rowing Association, and Messrs. F. E. Findlay and R. C. Widgery, of the Ballarat Rowing Association.

The organising committee is greatly indebted to the sponsors of the King's Cup Regatta, W. D. & H. O. Wills (Aust.) Ltd., and their Victorian executives, for the many kindnesses shown during the regatta, and for ensuring the financial success of the regatta.

The committee also wishes to thank the Mayor, Councillors and Officers of the City of Ballarat, the many individuals in Ballarat and Melbourne and the members of the Victorian and Ballarat Rowing Associations, who all made a great contribution in running an outstandingly successful regatta.

Messrs. A. N. Jacobsen and G. H. Nicholson were elected selectors, and they appointed Mr. D. H. Boykett, the coach of the Mercantile crew which won the Victorian eight-oared championship, as Victorian coach and third selector.

The following crew was selected: D. Bishop (Monash), 13 st. 2 lb., bow; J. Shanasy (Mercantile), 12 st. 12 lb., 2; K. Jelbart (Monash), 14 st. 2 lb., 3; P. Guest (Banks), 14 st. 7 lb., 4; J. Harry (Mercantile), 15 st. 8 lb., 5; D. Douglas (Mercantile), 14 st. 5 lb., 6; S. Gillon (Mercantile), 12 st. 6 lb., 7; G. Boykett (Mercantile), 13 st. 2 lb., stroke; G. Godkin (Mercantile), cox; W. Liley (M.U.B.C.), 13 st. 12 lb., and D. Palfreyman (Mercantile), 12 st. 10 lb., emergencies.

Mr. R. H. Richardson, of Mercantile Rowing Club, was elected manager.

The course was in perfect condition, and although the weather could have been better, it did not rain during the regatta, and the wind did not appear to materially affect the course or the performance of any of the crews or scullers.

The results of the heats and repechages held on Friday morning and afternoon respectively were:

First Heat: 1st, Victoria; 2nd, Western Australia. Time, 7 min. 3 sec. Margin, 12.8 sec.

Second Heat: 1st, Tasmania; 2nd, New South Wales. Time, 6 min. 59.3 sec. Margin, 45 sec.

Third Heat: 1st, South Australia; 2nd, Queensland. Time, 7 min. 9 sec. Margin, 18 sec.

Repechage: 1st, New South Wales; 2nd, Western Australia; 3rd, Queensland, Time, 6 min. 59 sec. Margin, 8.9 sec.

The final on Saturday afternoon was won by Victoria from South Australia, Tasmania and New South Wales, in that order. The winning time was 6 min. 24.1 sec. The margins were 0.7 sec. between first and second, 0.6 sec. between second and third, and 8 sec. between third and fourth.

Victoria was favoured to win due to the fact that there had only been one change in the crew which was so successful last year.

South Australia jumped away at the start, followed by Tasmania, Victoria and New South Wales in that order. At the 500 metres mark, South Australia led Tasmania by 0.1 sec. with Victoria running a very close third.

Tasmania had taken the lead at the 1,000 metres mark, but South Australia and Victoria were running second and third by only the smallest of margins, and New South Wales had dropped about half a length behind.

At the 1500 metres mark, South Australia, Tasmania and Victoria were dead level, all passing that mark in 4 min. 46.2 sec. South Australia were leading about 300 metres from the finish, but the Victorian crew lifted the rating and streaked across the line just ahead of South Australia and Tasmania.

Most rowing enthusiasts agreed that it had been many years since spectators had witnessed such a great finish between three crews.

We congratulate the Victorian crew and coach on their great efforts.

The Association was honoured to have had His Excellency, The Governor of Victoria, Major-General Sir Rohan Delacombe, K.C.M.G., K.B.E., C.B., D.S.O., K.St.J., in attendance to present the perpetual trophies to the winning crews and sculler.

We were also very pleased to have had as guest the three surviving members of the A.I.F. crew, which won the King's Cup for Australia in 1919, namely, Dr. Clive Disher (Victoria), stroke; Mr. Fred House (Tasmania), 2; and Mr. Tom McGill (N.S.W.), 3.

The traditional King's Cup picnic was held at Dowling Forest Racecourse and the Association wishes to acknowledge the splendid work of the Old Oarsmen's Association in planning and running this most successful get together.

AUSTRALIAN SCULLING CHAMPIONSHIP (PRESIDENT'S CUP)

The Victorian representative was R. Fitch (12 st. 7 lb.), of the Barwon Rowing Club.

Results of heats and repechages were:-

First Heat: R. Reddel (New South Wales), 1st; R. Fitch (Victoria), 2nd; M. Reynolds (Queensland), 3rd. Time, 8 min. 51 sec. Margin, 8.9 sec.

Second Heat: R. G. Free (Tasmania), 1st; N. Talbot (South Australia), 2nd. Time, 8 min. 37.8 sec. Margin, 24.1 sec.

Repechage: N. Talbot, 1st; M. Reynolds, 2nd; R. Fitch, 3rd. Time, 8 min.

55 sec. Margin, 11.2 sec.

In the final, the defending champion, Reg Free, of Tasmania, won the event from N. Talbot, with R. Reddel and M. Reynolds finishing third and fourth respectively. The winning time was 8 min. 10 sec., and the winning margin 6.2 sec.

Congratulations are extended to Reg. Free on his second consecutive Australian championship sculling victory.

AUSTRALIAN LIGHTWEIGHT FOUR-OARED CHAMPIONSHIP (PENRITH CUP)

The crew selected to represent Victoria consisted of: B. Clarke, bow; A. McKinley, 2; T. Johnston, 3; P. Nicholson, stroke and A. Richards, cox, all members of the Melbourne University Boat Club, and C. Barton (South Melbourne) and T. Hogan (Mercantile), emergencies. Dr. M. Schapper, of the Melbourne University Boat Club, was the coach.

Second Heat: South Australia, 1st; Western Australia, 2nd. Time, 8 min.

Third Heat: New South Wales, 1st; Tasmania, 2nd. Time, 8 min. 27.8 sec. Margin, 11 sec.

Repechage: Western Australia, 1st; Tasmania, 2nd; Queensland, 3rd.

Time, 8 min. 4.2 sec. Margin, 12 sec.

Final: In a very exciting finish, South Australia won the race from New South Wales by 2.8 sec., with Victoria and Western Australia in a dead heat for third. The time was 7 min. 38.4 sec.

It was the first South Australian victory since the inception of the event in 1958, and our congratulations to extended to the crew.

ALL JAPAN CHAMPIONSHIP REGATTA

The Melbourne University Boat Club was invited to send a team to the Championships, held on the Toda Olympic Course on 30th and 31st August, 1969. The team comprised an eight, coxed pair and coxless pair.

A summary of the results follows:

Eights Final: Won by Doshisha (the Japan Olympic crew), with Keio 2nd, Melbourne 3rd, Tokyo 4th and Waseda 5th in 6 min. 4.3 sec.

Coxed Pair Final: Won by Melbourne by over four lengths from Tokyo Nautical College, with Nigata 3rd and Tokyo Technical 4th. Time, 8 min. 3.8

Coxless Pair Final: Won by Hosei from Melbourne, with Nakamura Steve-doring Co. 3rd and Tokyo Medical and Dental 4th. Time, 7 min. 28.7 sec.

From all reports, the visit was a great success and our congratulations are extended to Melbourne University on their fine efforts.

Blades - from tip - two inches white, two inches green, two inches gold, two inches green and the rest of the blade white.

Add Rule 2-17 (a): "Every oarsman who is affiliated with a State Association shall be a contributing member of the Australian Amateur Rowing Council by reason of the affiliation fee, contributed to the funds of the Council by the Association in respect of his affiliation.

European Rowing Championships.

Approval was given to R. G. Free, the current holder of the President's Cup for single sculls, to compete at the Championships in Klagenfurt, Austria, on 10th to 14th September, 1969. Free was eliminated in the semi-finals, coming 4th in 7 min. 20 sec.
