

THE VICTORIAN ROWING ASSOCIATION

The Ninety-eighth Annual General Meeting of the Victorian Rowing Association will be held at the Amateur Sports Club of Victoria, 14 McKillop Street, Melbourne 3000, on Saturday, 31st August, 1974, at 8.00 p.m.

BUSINESS

- 1. To confirm the Minutes of the Ninety-seventh Annual General Meeting. held on Saturday, 25th August, 1973. 2. To receive the Ninety-eighth Annual Report and Balance Sheet. 3. To elect Office-bearers, viz. President, eight Vice-presidents and two

- 6. To consider amendments to the Constitution, Rules and Regatta Regulations and Laws of Boat Racing, of which due notice of motion has been given.
- (a) Submitted by the Executive Committee-RULES.

Amend Rule XIII to read-

No club within a radius of twenty (20) miles of the General Post Office, Melbourne, shall appoint a representative member to the Committee unless there shall have been paid to the Treasurer of the Association, on or before the fifteenth day of October in each year, on behalf of the said Club, the sum of \$1.50 in respect of every member of such Club. No Club without a radius of twenty (20) miles of the General Post Office, Melbourne, shall appoint a representative member to the Committee unless there shall have been paid to the Treasurer of the Association, on or before the fifteenth day of October in each year, on behalf of the said Club, the sum of \$1.20 in respect of every member of such Club. CONSTITUTION.

Amend Clause VI (a) to read-

Subject to Rule XIII, each Club belonging to the Association may appoint representative Members to the Committee under the following conditions, viz .:--

Clubs within a radius of 20 miles of G.P.O., Melbourne-

paying \$75 or less 1 representative paying more than \$75 2 representatives Clubs without a radius of 20 miles of G.P.O., Melbourne-

paying \$60 or less 1 representative paying more than \$60 2 representatives

Such members shall hold office until the end of the financial year for or during which they may be appointed and shall be called Representative Members.

Amend Clause XII (b) to read-

The Association shall transfer from the funds of the Association annually to the Capitation Fund the sum of Fifty Cents (50c) in respect of each affiliated member of the Association. RULES.

Amend Rule XXXI to read-

At General Meetings of the Association the Members of any Rowing Club within a radius of 20 miles of the G.P.O. Melbourne, shall not exercise a greater number of votes than one for each \$1.50 paid by such Club under Rule XIII, and the members of any Rowing Club without a radius of 20 miles of the G.P.O. Melbourne, shall not exercise a greater number of votes than one for each \$1.20 paid by such Club under Rule XIII.

Note:---If adopted, the preceding amendments to Clauses VI (a) and XII (b) of the Constitution and Rules XIII and XXXI will not take effect until 1st October, 1975, for the 1975-76 season.

Delete existing Rule XXXIV and substitute therefor the following Rule XXXIV-

(i) The State Premiership shall be awarded to the Club winning the highest number of points computed according to the following conditions:-

Points shall be awarded to winning crews and scullers for all qualifying and youth races conducted at championships and regattas approved and registered by the Association. Points shall be awarded in respect of each oarsman and sculler who wins a gualifying race or youth race in the following classifications:

Senior Events	
Junior Events	2 points per man
Lightweight Events (except	Lwt. Maiden) 2 points per man
Lightweight Maiden Event	s 1 point per man
Maiden Events	1 point per man
Novice Events	1 point per man
Youth Events	1 point per man

(ii) In addition a Pennant shall be awarded to the Club scoring the highest number of points as computed under Rule XXXIV (i) in the following divisions:-

Junior Second Division Pennant for Junior & Maiden Events Lightweight Pennant for Lightweight Events Youth and Novice Pennant for Youth & Novice Events

Senior Pennant for Senior Events Junior First Division Pennant for Junior & Maiden Events

(iii) Should two or more Clubs be equal first on points at the end of the season, then the Premiership and/or Pennant shall be awarded to the Club on equal first that has had the most crew wins.

(iv) JUNIOR FIRST DIVISION PENNANT

The First Division shall consist of the following ten affiliated Clubs of the Association who qualified according to the Rules at the end of the 1973-74 season:- Barwon, Corio Bay, Mercantile, Power House, Banks, Hawthorn, Wendouree-Ballarat, Melbourne, Melbourne University and Essendon.

JUNIOR SECOND DIVISION PENNANT

The Second Division shall consist of all other affiliated Clubs of the Association not in the First Division.

Notwithstanding anything contained in the previous two paragraphs, provided the Club which scored the most number of points in the Junior Second Division, scored more points in the Junior Pennant than the Club which scored the lowest number of points in the Junior First Division, such Club shall be promoted from the Junior Second Division to the Junior First Division and the Club scoring the lowest number of points in the Junior First Division shall be relegated to the Junior Second Division.

Should two or more Clubs have the equal lowest number of points scored in the Junior First Division, then that Club with the lowest number of points and the least number of crew wins shall be the Club to be relegated to the Junior Second Division.

(v) Races other than championships and races at National Regattas held on the River Murray, registered by the South Australian Rowing Association and at Griffiths, N.S.W., registered with the New South Wales Rowing Association, held on dates other than dates on which a Victorian qualifying regatta is to be held, won by Clubs affiliated with the Victorian Rowing Association shall count for points as awarded in this Rule in the Victorian Premiership and Pennants, provided such races come under the classifications of

the Association in accordance with Para 2 of Regatta Regulations and Laws of Boat Racing.

Amend the first part of Rule XV (2) (b) to read-

Each Club shall pay to the Association in each year the sum of \$60 in respect of each of its members selected or elected (as the case may be) in that year to become:—

Amend Rule XV (2) (c) to read-

All sums payable by Clubs to the Association pursuant of sub-rules (a) and (b) of this Rule shall be paid at least twenty one (21) days prior to the departure of the team.

Delete Rule VII (c) 8 and substitute therefor:

8. Entry fee, excluding any levies which may from time to time be imposed by these regulations.

Delete Rule VII (m) and substitute therefor:

(m) The regatta equipment owned by the Association shall be made available to each Regatta Committee at no charge provided that the Regatta Committee shall remit to the Treasurer of the Association the amount specified for equipment as shall be charged in addition to the entry fee.

The Executive Committee of the Association shall determine the equipment required for the conduct of each regatta.

The Regatta Committee shall arrange for its nominated representative to accept delivery of the equipment at a time and place nominated by the Honorary Secretary of the Association and shall arrange for its installation under the supervision of a representative of the Executive Committee. The Regatta Committee shall further arrange that all Regatta Officials who do not hold a Regatta Officials Licence as provided by these regulations and who will be using any of the equipment to be suitably instructed in the use thereof by a representative of the Executive Committee prior to the commencement of the regatta.

At the conclusion of the regatta the Regatta Committee shall arrange for its nominated representative to return all Regatta Equipment at the time and place nominated by the Honorary Secretary of the Association.

REGATTA REGULATIONS AND LAWS OF BOAT RACING.

Regulations 6 (a)-

After the words 'the amount of entrance fees' in the 3rd line insert the following:— "together with any levies charged by the Association,"

Delete Regulation 6 (e) and substitute therefor:

6 (e) In addition to the entrance fee there shall be charged on each entry a levy of 15c per oar which shall be appropriated 5c per oar as to the King's Cup levy and 10c per oar as to the Regatta Equipment levy. These levies shall be collected by the Committee conducting the regatta and shall be paid to the funds of the Association. The entrance fee for each competitor, excluding the aforementioned levies, in any race rowed under these regulations and laws or under the control or with the approval of the Association shall not exceed \$1.00 and shall be not less than 30 cents.

Delete Regulation 2 (w) and substitute therefor:

2 (w) (1) Youth rowing races shall be open to amateurs who are members of club or school crews and who are within the age limit laid down from time to time by the A.A.R.C., even though a member or members of such crew may have won rowing or sculling races in any other classification. The oarsman shall cease to be eligible to compete in youth rowing races on 31st December of the year in which he reaches the said age limit, as laid down by the A.A.R.C.

(2) Junior youth rowing races shall be open to amateurs who are members of club or school crews aged 16 and under, even though a member or members of such crews may have won rowing or sculling races in any other classification. The oarsman shall cease to be eligible to compete in junior youth rowing races on 31st December of the year in which he reaches the age of 16 years. (3) Notwithstanding anything contained in the preceding two sections of this sub-Regulation, when entries for regatlas to be held prior to January 7th in the succeeding year close prior to 31st December, an oarsman who is eligible to compete in a youth rowing race or a junior youth rowing race at the date of the closing of the entries shall be permitted to compete and win such event.

Amend Regulation 2 (v) (1) (ii) to read-

A rowing, single sculling or double sculling race for competition between representatives of two or more Universities, or two or more University Colleges, or a youth rowing race.

Add Regulation 2 (ab)-

An oarsman, once selected in a representative Victorian crew, is not permitted to compete for his Club, University or School, whilst a member of such crew, in any capacity other than as a member of the said crew.

Victorian crews selected to represent their State or Australia in Interstate or International events, shall be ineligible, except by invitation, to compete in Victorian qualifying regattas except that when the particular crew is comprised completely of affiliated members from the same Victorian Club, University or School it shall be eligible to compete in the name of that Victorian Club, University or School.

(b) Submitted by Essendon Rowing Club-

REGATTA REGULATIONS AND LAWS OF BOAT RACING.

After sub-clause (b) of Regulation 28 add sub-clause (bb) as follows:---

(bb) Notwithstanding anything contained in Regulation 28 (b), where there are five (5) or less than five (5) entries received for any event conducted under these regulations and laws or under the control or with the approval of the Association, the total value of the trophy or trophy order provided by the Regatta Committee for each oarsman and coxswain of the winning crew in such event shall be not less than the total amount of entry fees received by the Regatta Committee for such event.

(c) Submitted by Footscray City Rowing Club-RULES.

Rule XXXV-A (ix) (a) be deleted and substitute therefor-

(a) A Club may, with the approval of a General Committee Meeting, combine with another Club to compete in qualifying regatta races during the forthcoming regatta racing season.

Rule XXXV-A (ix) (d)-

Delete the words "executive committee" and in its place insert the words "General Committee".

NINETY-EIGHTH ANNUAL REPORT AND BALANCE SHEET OF

THE VICTORIAN ROWING ASSOCIATION

To the Members, Victorian Rowing Association. Gentlemen,

Your Committee has pleasure in presenting the Ninety-eighth Annual Report, together with the audited Balance Sheet and Accounts covering the 1973-74 rowing season for the year ended 30th June, 1974, respectively.

Probably the most outstanding feature of an extremely busy and successful season was the presentation of the first combined King's Cup and National Regatta on Lake Wendouree, Ballarat, over the Easter period. This event was an outstanding success and gave enthusiasts the greatest feast of rowing since the 1956 Olympics, also at Ballarat, and the Association wishes to thank all of those members who gave of their time and effort to assist in the conduct of the regatta.

The performance of the Victorian Eight was somewhat disappointing when they did not reach the final of the King's Cup; however, this was offset by the fine win of the Lightweight Four in the Penrith Cup and the performance of the Victorian Single Sculler and Youth eightoared crews.

Early in the season Victorian oarsmen represented Australia in two international events — the European Rowing Championships at Moscow and the F.I.S.A. Junior Championships at Nottingham. In Moscow the three Australian crews each competed in the Little Finals of their events, indicating that our standard is still not quite up to that of the leading rowing countries. At Nottingham the crew finished eighth overall against the best Junior Eights in the world, which was a pleasing performance for Australia's first entry into this class of world competition. Details of both these regattas are listed later in this report.

At the time of writing this report Victorian oarsmen are again preparing to represent Australia overseas, this time at the World Rowing Championships to be held at Lucerne, Switzerland, in September, and this Association wishes the Lightweight Four and Mr. W. G. Magennis, who will be competing in the Coxswainless Four, together with all other members of the Australian team, every success in their quest for gold medals.

In the competition for State Premierships, Melbourne University Second Division Premiership and Mercantile Rowing Club won the Junior First Division Premiership, Essendon Rowing Club won the Junior Second Division Premiership and Mercantile Rowing Club won the Lightweight Premiership and your congratulations are extended to all these Clubs.

The members of the Australian Amateur Rowing Council, under the chairmanship of Mr. A. W. McLiesh, and its Honorary Secretary, Mr. R. G. Blundstone, O.B.E., again did their utmost to ensure that Australian rowing was promoted to the fullest. Mr. Reg. Blundstone has resigned from his position as Honorary Secretary and we thank him for his 15 years of service in this position and congratulate Mr. Jack Pritchard, of Queensland, on his election as Honorary Secretary of the Council.

Again this season, but on a reduced scale, the Youth Rowing Sub-Committee, under the auspices of the Rothmans National Sports Foundation, conducted a number of coaching seminars throughout Victoria, which were well received by all who attended them, and the Association's thanks go to the members of the Sub-committee for their efforts to promote youth rowing. The original three-year appointment of this sub-committee has now expired, and with the appointment of a new secretary, Mr. M. J. Rowan, the Association is looking to reform the sub-committee to continue its important and successful work in promoting the sport of rowing, especially among the youth of the community.

On a sadder note, the death of Mr. M. S. Williams, who has been President of the Association for twenty years, was a blow to Victorian rowing and rowing in general and he will be sadly missed by all who knew him.

Again this season a rowing club suffered a severe setback when on November 25, 1973, the Yarrawonga Rowing Club premises and fleet of boats were completely destroyed by fire. With assistance from other rowing clubs the Yarrawonga Rowing Club is still functioning and its members are hopeful of obtaining new premises in the near future.

The Old Oarsmen's Association again gave splendid support to the Association and its executive and members are to be thanked for their assistance, which was always so readily given. This support, from such a solid core of supporters whose sole aim is to see Victorian rowing prosper, is in no small way one of the reasons for the success currently being enjoyed by Victorian Rowing.

Australian Universities Rowing Championships

The Championships this year were held on the Nepean River at Penrith, N.S.W., with heats and repechages on Friday, 24th May, and finals on Saturday, 25th May, 1974.

The eight-oared championship for the Oxford and Cambridge Cup was won by Adelaide from Melbourne with Monash 3rd.

The lightweight four-oared championship for the Sir Fred J. Schonell Cup was won by Adelaide with Melbourne 2nd and Sydney 3rd.

The coxswainless pair-oared championship for the Carlton and United Goblets was won by Melbourne from Western Australia with Tasmania 3rd.

The sculling championship for the W. D. & H. O. Wills Trophy was won by R. Bleakley (Queensland) from A. Whitworth (Melbourne) with N. Newton (Latrobe) 3rd.

Inter-Collegiate Rowing

The Mervyn Bournes Higgins Trophy for first eights was won by Trinity College from Ormond College by one and a half lengths in 7:12. In the losers final Newman College defeated Queens College by one and one-third lengths in 7:19.

The Malcolm Russell Norton Shield for second crews was won by Ormond College, for the tenth year running, from Trinity College, margin easily. The Clive Disher Challenge Cup for annual competition between Extra Collegiates, Monash University and Latrobe University, was this year won easily by Extras, who defeated Monash by five and a half lengths with Latrobe well back third. This was the first year that Latrobe had competed.

The John Lang Cup for annual competition between Extra Collegiates and the winning Inter Collegiate first crew was won by Extra Collegiates who defeated Trinity College by two and a half lengths in 6:12. The Extra Collegiate second crew easily defeated Ormond College second crew in 5:28.30.

The past season was a busy one for officials by virtue of the greatly increased number of regattas held, culminating in the King's Cup and National Regatta and the usual Easter Regattas at Mildura and Wentworth. These officials were in marked contrast to a number who made themselves available on only one or two occasions and to some others who did not even reply to availability questionaires.

Gosling (Banks), P. Harding (Mercantile), C. R. Reynolds (Barwon), R. J. Nankervis (Banks), M. J. Rowan (Banks), K. M. Bourke (Footscray,) G. M. Taylor (Mercantile), C. J. Lehman (Banks), W. F. Humphreys (Horsham), L. W. B. Smith (Horsham), Evan Gazelle (Dimboola), J. S. Kemfert (Dimboola), I. Kuhne (Dimboola), R. Baird (Wentworth), C. W. Evans (Wentworth), R. J. Lane (Wentworth), and S. K. Woods (Wentworth).

The Panel is sure there are many former oarsmen not actually engaged in coaching, but who would have time to act as officials on occasions during the regatta season. It looks to Club Committees and Executives to persuade these members to take the test for an official's licence and so ease the burden on existing officials.
