# ONE HUNDRED AND SECOND ANNUAL REPORT AND BALANCE SHEET OF

## THE VICTORIAN ROWING ASSOCIATION

To the Members, Victorian Rowing Association, Gentlemen.

Your Committee has pleasure in presenting the One Hundred and Second Annual Report for the 1977-78 rowing season, together with the audited Balance Sheet and Accounts for the year ended 30th June, 1978.

The season under review started on a high note with the success of the Australian Lightweight crews at the World Rowing Championships in Amsterdam, when the Lightweight Four won a Silver Medal, the Lightweight Eight won a Bronze Medal and the Lightweight Sculler finished fourth, which earned Australia the title of the most successful Lightweight nation at the Championships. With Victorian oarsmen in the majority among the Lightweight crews this result has given Lightweight rowing in Victoria an even greater boost. As this report is being prepared another Australian Team, comprising sixteen Victorians in a team of nineteen, is in Europe preparing to defend their title at the World Lightweight Rowing Championships to be conducted at Copenhagen and to all members of the team we extend our best wishes for success.

However, whilst Lightweight rowing in Victoria is riding on the crest of a wave, other aspects of rowing in Victoria seem to be standing still. The Association may be the cldest Rowing Association in the World but let us look upon our entry into the second hundred years as a rebirth and not with the tiredness of old age.

Who is "the Victorian Rowing Association?"

You are the Association, the club and the members, so let us all strive to develop and promote our sport, whether it be by serving on a committee, assisting or competing at a regatta, encouraging and teaching newcomers or the many other facets of Association activity.

During the season most regattas were strongly supported with some close decisions between very competitive crews and scullers. In the competition for State Premierships, Monash University Rowing Club won the Senior Premiership, Melbourne University Boat Club won the Lightweight Premiership, Barwon Rowing Club won the Junior First Division Premiership and Melbourne Rowing Club won the Junior Second Division Premiership and we extend our congratulations to all these Clubs.

The combined King's Cup and National Regatta was conducted on the Huon River at Franklin, Tasmania, with the National Regatta attracting record entries. Victoria finished second to New South Wales in the final of the King's Cup, while the Victorian Lightweight Four continued its dominance of this event. The Single Sculler attained a very creditable fourth place while the two Youth Eight crews were placed in third and sixth positions.

At the National Regatta Victorian crews were successful in winning the Lightweight Eight, Lightweight Four without Cox, Lightweight Scull and School Eight events.

The Australian Amateur Rowing Council, under the chairmanship of Mr. R. R. Aitken, devoted many hours to ensure that Australian rowing was promoted to the fullest and the thanks of the Association are extended to all concerned. We sincerely thank Mr. Jack Pritchard for his efforts and assistance over the past four years as Honorary Secretary of the Council and congratulate Mr. John Coates, of New South Wales, on his election to this position.

The Department of Youth, Sport and Recreation of Victoria again provided support and assistance in many fields of Association activity for which we are most grateful. The main activity, the promotion of rowing, was handled by the very active V.L.R.A./V.R.A. Promotion Committee who, with the assistance of local clubs, conducted ten rowing promotions aimed at recruiting new members into the clubs, as well as promoting the sport at the 1978 World Sports Expo held in Melbourne. The results of their efforts can be seen in the increased membership and activity at a number of clubs and all members are urged to adopt the theme "Get Together Rowing" and do their utmost for the development of the sport.

In memory of the late David S. Stirling, a tireless worker for the Association and a friend to all coxswains and lightweight oarsmen, the members of Lodge Henley presented to the Association a magnificent perpetual trophy, which is to be awarded annually to the winners of the Victorian Champion Lightweight Four event, and we are most grateful to these people for their fine gesture.

As always, we are again most appreciative of the support and assistance so freely given by that fine body of "retired" oarsmen whose sole aim is to see Victorian rowing prosper, the Old Oarsmen's Association of Victoria and to its executive committee and members we say a most sincere thank you.

During the season your Association was pleased to participate in the commemoration of the 25th year of Queen Elizabeth II's reign as our Monarch and following the V.R.A. (Melbourne) Regatta, at which winning crews were presented with trophies marking the Queen's Silver Jubilee, the Association was able to make a suitable contribution to The Queen's Silver Jubilee Appeal for Young Australians.

Members of the Association who have not already made their arrangements to visit New Zealand in October-November, 1978, are again reminded of the ideal opportunity to see some of the world's best oarsmen in action and also to support a large Australian Team, when the World Rowing Championships are conducted in a neighbour country.

# AUSTRALIAN EIGHT-OARED CHAMPIONSHIP

The combined King's Cup and National Regatta together with the Australian Women's Rowing Championships were conducted on the 2000 metre rowing course on the Huon River at Franklin, Tasmania. The Interstate Championships were conducted on Thursday 23rd and the morning of Saturday, 25th March, whilst the National Championships commenced on the afternoon of Saturday 25th and continued through to the late afternoon of Monday, 27th March, an extremely lengthy programme of 168 events which, with scratchings and non-appearance of crews, reduced to 139 actual events.

The regatta was conducted in cool weather with the varying wind providing a great variation in rowing conditions.

At the conclusion of the Victorian Eight-oared Championship the State Selectors named a spad of sixteen oarsmen and two coxswains for selection of the crew to represent Victoria in the king's Cup and after some weeks of trials and tests the crew was selected as follows: S. Shirrefs (Mercantile) bow, R. Guy (Mercantile) 2, A. Sloan (Mercantile) 3, J. Lowe (M.U.B.C.) 4, W. Magennis (Monash) 5, T. Young (Monash) 6, K. Jelbart (Monash) 7, B. Richardson (Monash) stroke, M. Aitken (Mercantile) cox, L. Ljubanovic (Monash) and C. Rawson (Monash) emergencies, C. Dane (Monash) coach.

Mr. K. M. Bourke, of Footscray City Rowing Club, was appointed team manager.

On the eve of their departure for Tasmania, T. Young was forced to withdraw from the squad due to ill health and was replaced by A. Withers of Mercantile Rowing Club.

The results of the heats and repechage, held on Thursday, were:

First Heat: 1st, South Australia; 2nd, Tasmania; 3rd, Queensland. Time, 7 minutes 25.4 seconds. Margins, 8.6 and 5.2 secs.

Second Heat: 1st, New South Wales; 2nd, Victoria; 3rd, Western Australia. Time, 7 minutes 16.4 seconds. Margins, 17.0 and 11.0 secs.

Repechage: 1st, Victoria; 2nd, Tasmania; 3rd, Queensland; 4th, Western Australia. Time, 6 minutes 46.4 seconds. Margins, 3.0, 9.9 and 8.3 secs.

The final on Saturday morning resulted in a win for New South Wales, their fifth success in a row with Victoria 2nd, Tasmania 3rd and South Australia 4th. The winning time was 6 minutes 5 seconds with margins of 3.0, 4.9 and 8.1 seconds.

The New South Wales crew got away to an excellent start to be a canvas ahead of Victoria and Tasmania after 200 metres and by the 1000 metre mark had increased this to a three-quarter length lead. At about 1300 metres Victoria threw out the challenge to New South Wales with a great effort, to be level at the 1600 metre mark, but were unable to match the New South Wales final sprint which took them over the line ahead of Victoria, Tasmania and South Australia.

Again we congratulate the New South Wales crew and their coach on another fine win and their selection to form the basis of the Australian Eight for the New Zealand World Rowing Championships.

### PROMOTIONS COMMITTEE

After a successful beginning during the 1976-77 season and the assistance of a further State Government grant to rowing through the Department of Youth, Sport and Recreation, the joint promotions committee of Kath Bennett, Anne Chirnside, Ray Hammon, Rosemary Hoffman, Caroline Judd, Ruth Klinge, Terry Murphy, Martin Owen, Dot Rycroft and Bill Waterfield, continued their efforts to increase the participation in our sport.

Commencing early in the season and using their established programme of publicity and involvement, Get Together Rowing promotions were conducted at Mildura, Robinvale, Wentworth, Footscray and the rowing clubs on the Yarra River at Princes Bridge. The response of both men and women at all these venues was commensuate with the input of the clubs concerned and following the promotions some of the clubs have been enjoying an increase in membership and local awareness of our sport.

The Committee, mainly through the efforts of the women members, and with the sponsorship of G.R.E. Insurance, was involved with the World Sports Expo staged at the Exhibition Buildings, Melbourne, in February and the rowing stand was one of the Exhibition's highlights, with over 70,000 people who visited the show having the opportunity to try rowing and receive expert tuition. Each evening, representatives from affiliated women's clubs staged exciting match races on the rowing ergometers and the final match was one of the features on the last day of the Exhibition and was rowed before a capacity crowd in the Western Annex arena, with presentations to the winner and runner-up being made by Mr. J. D. L. Lush, General Manager/Operations of G.R.E. Insurance. Involvement with activities such as this helps to make the general public aware of our sport and our message reached a large number of both male and female prospective participants.

In addition to all this activity, the Committee have been engaged in the compilation of an administrative handbook and a promotional display kit during the season and, in anticipation of further State Government assistance for rowing promotion, have already planned activities for the 1978-79 rowing season to assist clubs recruit new members and to promote our sport to the public in general.

## OFFICIALS' PANEL

Todd (Yarrawonga) and our first lady official Ms. R. Klinge (Y.W.C.A.).

Some ten Victorian officials holding Australian Licences made themselves available for the King's Cup and National Regattas in Hobart and from all accounts made a considerable contribution to the number officiating.

No Victorian officials submitted themselves for Australian licences this season but congratulations go to Reg McKay who was successful in obtaining his F.I.S.A. Licence at Amsterdam. Further congratulations go to Reg on his selection as one of the two Australian F.I.S.A. licence holders to officiate at the World Rowing Championships in New Zealand later this year.

Season 1977-78 marked the retirement of Messrs. N. W. Cairnes, T. Rodda, A. W. McLeish and K. S. Cusworth from the ranks of the active regatta officials. All four have given many years of service in this sphere and deserve the thanks of all

competing oarsmen.
