To the Members, Victorian Rowing Association,

Ladies and Gentlemen,

It is with pleasure that your Committee presents the One Hundred and Eighth Annual Report for the 1983-84 rowing season, together with the audited Balance Sheet and Accounts for the year ended 30th June. 1984.

The Association has been delighted that Pilkington A.C.I. Limited, through their sponsorship and support, have provided an important incentive for Victoria's oarsmen and women this season. Pilkington A.C.I., a supplier of products to the Australian building, automotive and domestic appliance industries, felt a corporate responsibility to support some form of Australian endeavour and we are more than thrilled that they chose rowing. The sponsorship monies and support have benefited all rowing clubs and schools in Victoria and all Association Regattas and Championships. The Victorian King's Cup Eight was named the Pilkington A.C.I. and we were delighted to have the Company's entire executive board from England present at the christening outside Banks Rowing Club. As a further incentive for the coming season Pilkington A.C.I. have committed themselves to an ongoing sponsorship which includes the Australian Rowing Championships to be held in Victoria.

As has been the custom in recent years the season opened with our attention held by the performance of Australian crews at the World Championships in Duisburg. West Germany, the F.I.S.A. Junior Championships in Vichy, France, and the Senior B Competition in New Zealand. We congratulate the Men's Eight on winning a Bronze Medal, our first Medal in heavyweight rowing since 1968, and the Lightweight Eight on winning a Silver Medal, our best result ever in Lightweight Eights. The Senior B Team completely dominated each of the four Regattas against New Zealand and our congratulations are extended to all members of the team for a marvellous performance.

At the King's Cup Regatta held on the excellent new international standard course at Lake Barrington, Tasmania, Victorian crews were to the fore winning five of the seven Interstate Championship events, President's Cup, Penrith Cup, Wilkinson Trophy, U.L.V.A. Trophy and the Victoria Cup and we congratulate all members of the Victorian Team on their excellent performance.

At the combined National Championships, Victorian oarspeople were successful in winning ten of the forty events conducted while others were narrowly defeated. Following on from comments in the previous Annual Report a number of Challenge events were conducted at Lake Barrington to cater for oarspersons who were not competing in either the National or Interstate Championships. While these events were not Championship events it is felt that it was a step in the right direction towards a true National Championship and needs your full support in future years if the indicated wishes of most Victorian clubs are to be achieved.

As this report is being prepared, Victorian oarsmen and women are again preparing for international competition as part of the largest and best qualified National Rowing Team to ever represent Australia. Including managers, coaches and doctors, the total is one hundred and two, of which forty one are Victorians, and the various sections of the team will compete at the Olympic Games, F.I.S.A. Lightweight Championships, F.I.S.A. Junior Championships and in Senior B competition against New Zealand here in Australia. While the selection of all crews was long and exhaustive and each individual has proven his value as a capable representative, the task of financing such a team is akin to financing a large company. After Government and other grants and Australian Rowing Council levies, Victoria had \$73,000 to raise, the largest of any State, and our thanks and appreciation go to Mrs. Barbara Gillett, Victorian members of the teams and other supporters for their efforts to achieve this massive total.

The Association is grateful for the support, guidance and financial assistance received from the Department of Youth, Sport and Recreation in many fields of our rowing activities, particularly the salary subsidy for the State Director of Rowing. Our new State Director, Mr. Bob Lachal, has settled into the new office at Olympic Park and is actively engaged in servicing our sponsor company and the promotion and development of rowing. Through the Department many of our members have benefited from Victorian Sports Aid Foundation Grants to assist them in International competition.

The National Water Sports Centre — Carrum, in which the Department is actively involved, is making progress with the release of the Master Plan Study for its development and while the impact of the total cost has caused some Government hesitation the development is still alive and well.

During the Victorian Championship Regattas and the National Selection Trials held in Ballarat, we were pleased to entertain on your behalf members of the Ballarat City Council, representatives of our sponsors, Pilkington A.C.I., visiting members of the Australian Rowing Council and special guests as a token of appreciation for their efforts on behalf of rowing in Victoria.

During the season, there was good support for and strong competition at many of the regattas held throughout Victoria and for the State Premiership competitions. Your congratulations are extended to the listed clubs on their winning the following premierships — Mercantile Rowing Club won the Men's Champion Club, Men's Lightweight and Men's Junior First Division Premierships, Banks Rowing Club won the Men's Senior Premiership and Hawthorn Rowing Club won the Men's Junior Second Division Premiership. The Women's Champion Club and Women's Junior Premierships were won by Ballarat City Rowing Club and Melbourne University Ladies' Rowing Club won the Women's Senior and Women's Lightweight Premierships.

The Australian Rowing Council has had an active season in the management and promotion of Australian rowing and the thanks of the Association are extended to Mr. R. N. McKay, Victorian delegate, Mr. N. F. Wilkinson, Honorary Treasurer and other members and officials of the Council for their devotion. We extend our thanks to Mr. R. Batschi, National Director of Coaching, and Mr. C. Rawson, National Executive Director, for their assistance to Victorian oarsmen and women.

Congratulations are extended to Wendouree-Ballarat Rowing Club, another Victorian Club to reach the ripe old age of 100 years.

It was with disappointment that we recorded during the season the close of the Preston Rowing Club and the demise of the Albert Park Lake Regatta Committee. However, this has been somewhat offset by the addition of three new rowing schools — St. Mary's College, Loreto Convent and Sacre Coeur

Your congratulations are extended to William John Baillieu and Brian John Richardson, two well known Victorian oarsmen, on being awarded the Medal of the Order of Australia (O.A.M.) in the Australia Day Honors List for their part in the successful America's Cup challenge.

The Oarsmen's Association of Victoria again gave splendid support to the Association and its executive and members are to be thanked for their assistance, which is always so readily given. This support, from such a solid core of supporters whose sole aim is to see Victorian rowing prosper, is in no small way one of the reasons for the success of Victorian rowing.

The competition was conducted over four Regattas at Lake Karapiro, Wanganui, Invercargill and Christchurch, with Australian crews and scullers winning 38 of the total 52 events and returning to Australia with the three trophies awarded for competition between the two countries.

STATE DIRECTOR OF ROWING

The continuing financial assistance and support given towards the funding of our State Director and the promotion and development of rowing in general during the season by the Department of Youth, Sport and Recreation, is something for which the Association is extremely grateful.

Our new State Director, Mr. Robert P. Lachal, commenced duties on 1st August, 1983, and initially was involved in setting up a new office at Olympic Park, where he is readily available, and evaluating the work and programmes of Miss Anne Lelleton to maintain some continuity with the efforts she had made to introduce rowing in new areas.

A complete video system has been purchased and used effectively as a coaching aid at all levels. At the same time an extensive video library of training and rowing films has been established and is in great demand by clubs and schools. This library will continue to be expanded to serve all levels of rowing from beginners to elite.

Promotion of our sport has also been achieved by public displays at the Royal Melbourne Show, in the Bourke Street Mall and on television during the Channel 10 Olympic Telethon.

Soon after his appointment, Mr. Lachal was involved in the demand survey conducted as part of the feasibility study for the Water Sports Centre at Carrum which led to the publishing of a Development Master Plan.

In October, 1983, Mr. Lachal attended the Olympic Solidarity Coaching Seminar conducted by the New Zealand Rowing Association with lectures by world class coaches. In February, 1984, he duplicated this seminar and as much of the current information as possible was repeated for the benefit of nearly 100 Victorian coaches and interested parspeople who attended a most successful seminar.

During the season the State Director has been actively engaged in servicing the sponsorship of Pilkington A.C.I. Limited and cementing the relationship of the Association with this company and his efforts have been well rewarded in that the Company have committed themselves to an ongoing sponsorship for the 1984/85 season including the Australian Rowing Championships to be conducted by the Association at Ballarat

A number of promotional talks on rowing have been delivered and an amount of secondhand equipment has been organised to enable new Clubs and Schools to become active in the sport

Thanks are extended to Mr. Lachal for his efforts during his first season with the Association and to the members of the State Directions Committee who have assisted him in planning promotions, coaching seminars, outdoor displays and generally providing stimulation to develop and promote rowing throughout Victoria.

OFFICIALS' PANEL

This season has been one of the busiest and most problematical for the Officials' Panel with continuing problems as reported in the previous Annual Report.

The Panel officiated at 33 days of racing (3 more than 1982/83) at 14 courses, providing 482 officials (some 18 fewer than 1982/83). That we had to staff 22 days with only one shift of officials is of particular concern, as this is the highest rate to date and meant that a few officials had to put in several long and trying days. This task was made somewhat easier by our four new officials this season. Bruce Adam, Malcolm Chestney, Robert Kemp and Jim Patterson, to whom we extend our thanks for a good first season.

Whereas the Panel has a total strength on paper of 67, around 54 of these are active, including some 20 to 25 who form the solid core of officials who make the majority of our Regattas possible. We extend our thanks to them and all officials for a job well done. Once again, we thank Jim Skidmore and Jim Harvey for their assistance with equipment and correspondence respectively.

Looking ahead, hopefully we will be testing new officials later in 1984 and are examining a proposal to intake more country officials. All Clubs should seriously examine the problems outlined and take action to assist the Officials' Panel to carry out its tasks.

Our Chairman, Bill Morrison, has just retired from the Panel after some 20 years as an official, panel member and Chairman, a hearty vote of thanks is due to Bill for his long and dedicated service. Our special thanks are due to Reg. McKay, who is taking over as Chairman, Bob Duncan, Ron Podbury and Margaret Swan for their sterling service this season — and we welcome Ralph Murphy who joins the panel for 1984/85.

TREASURER'S REPORT

The financial statements disclose a satisfactory position but due in no small measure to the sponsorship received from Pilkington A.C.I. Limited. This year we had some extraordinary expenses, which the sponsorship enabled us to absorb without encroaching into normal income. Similarly we were able to pass on benefits to Clubs, Schools and Members which normally we would not have been able to do.

Without going into more detail at this point, we would refer members to the separate statement, which shows the full disposition of the sponsorship funds. In addition there was an interest factor pending the spending of the funds and the income therefrom was distributed to the Interstate and International Funds.

By raising the entry fee for the National Selection Trials we were able to reduce the loss on these events and the State Championships but the eventual deficiency is still large enough to warrant the search continuing for ways and means to further reduce it without lowering of our standards.

Regular items of expenditure were in the main contained within the level of inflation trends. A big rise in affiliation fees received will be noted, but it should be remembered this was due to the increase necessary to fund the State Directorate and is reflected in expenditure items in that sector.

The Interstate Investment Fund has now passed the \$100,000 mark. Income from this Fund is a major factor in holding the affiliation and other fees from Clubs to the Association at a very moderate level, when compared to other States.
