# THE VICTORIAN ROWING ASSOCIATION

To the Members, Victorian Rowing Association,

Ladies and Gentlemen.

Your Committee has pleasure in presenting the One Hundred and Ninth Annual Report for the 1984-85 rowing season, together with the audited Balance Sheet and Statement of Accounts for the year ended 30th June, 1985.

The season could be confidently described as one of many highlights which were distributed through most sectors of the Association's activities. We were delighted with the continuing sponsorship and support of Pilkington ACI Ltd. The sponsorship funds were this season supplemented by an extra grant towards the cost of staging the Interstate and National Regatta. Pilkington ACI throughout the season displayed a keen interest in Association activities, both on and off the water and the Organising Committee of the National Championships was very grateful for their involvement. As was the case last season the benefits to member Clubs and Schools from the sponsorship were mainly indirect and can be studied later in this report.

There were three other highlights and it is difficult to differentiate between them. The success of the Australian crews at the Los Angeles Olympic Games, FISA Championships and the Victorian members in those crews: the Australian Championships conducted by your Association and the successes of Victorian Club and State crews thereat and the record number of Victorian oarspersons gaining selection in 1985 Australian representative crews.

We congratulate the Mens Eight (Bronze Medal), Mens Quad Scull (Silver Medal), Womens Four (Bronze Medal) on their performances at the Olympic Games; the Womens Eight (Silver Medal) at the FISA Lightweight Championships and the all Victorian Junior Four crew (Bronze Medal) at FISA Junior Championships. Congratulations go also to the Victorian Lightweight men who represented Australia in Senior B competition against New Zealand for their 100% result in pair and four.

We believe the Association has set the highest standards possible in its conduct of Australian Championships in the past and believe this high standard was maintained at Lake Wendouree, Ballarat, in April this year. Despite inclement weather, the Championship Regattas were most successful and pleasing in respect of the financial result and the performance of Victorian competitors. Victoria regained the King's Cup and in doing so completed a clean sweep of the four mens Interstate events. Our ladies were not far behind in winning two of the three womens Interstate events. Victorian Club and School crews had outstanding success in the National Championships winning no less than 20 of the 47 events conducted.

As this report is being written. Victorian oarsmen and women, as members of Australian crews, are preparing for international competition in Europe and New Zealand. A total team of 88 includes coaches, managers, doctors and competitors and of these. 42 are Victorians, Such is the reward for success, but with success comes a price and this time it is \$42,000, which is Victoria's share of the \$85,000 to be raised to meet the teams' expenses. Our thanks go to Mrs, Barbara Gillett who, apart from being an Assistant Team Manager, is again leading the teams and supporters in their efforts to raise the necessary funds. The Association has continued to receive support, guidance and financial assistance from the Department of Youth. Sport and Recreation particularly in the field of finance for subsidising the activities of the State Director in promotion and development of our sport. The Department is also involved in supervising the (at present) temporary sports promotion officers, funded by the State Government under the scheme for unemployed Olympic Athletes. Your Association is receiving great benefit at present from the part-time work of David Doyle under this scheme. Several of our members have also benefited from the Victorian Sports Aid Foundation grants to assist in international competition.

Full development of the National Water Sports Centre at Carrum has, we understand, been deferred, but from information received it is believed that there is a plan being studied to commence construction perhaps this year, on a staged basis: the first stage being construction of the weir to form either a 1000 or 2000 metre course with perhaps basic facilities. We are assured the project has not been allowed to lapse and your Committee will continue to do all within its power to procure an international rowing course for Victoria.

In late 1984 revised Status Rules were adopted for Women, following which somewhat similar rules for Men were adopted in May last. The rules will take effect in the forthcoming season and reflect an increased emphasis on Under Age rowing whilst also retaining the previous grades albeit under different names and variations to eligibility. The regatta programme for 1985-86 is being drawn to cater for the new rules and there may be teething problems to overcome. If so, it is to be hoped that Clubs. Schools and competitors alike will understand that most things new have to go through a proving period before the desired result is obtained

Members will recall that the Association Honorary Secretary of 14 years standing. Mr. Bill Waterfield, retired at the 1984 Annual General meeting. In recognition of his outstanding work and service to Victorian Rowing your Committee, at the September 1984 meeting, unanimously conferred on him Life Membership of the Victorian Rowing Association, Since Bill Waterfield's retirement the Association has been without the services of a permanent Secretary. It has become obvious and is now generally accepted the workload of Secretary of the V.R.A. is beyond an unpaid volunteer unless there happen to be persons available who are: (a) sufficiently devoted to rowing: (b) have time on their hands and (c) are financially situated so as not to require financial reimbursement.

The activities of our State Director are reported on later, but it is appropriate at this stage to advise that at the final meeting of the Executive Committee for the season on June 27, Mr. Bob Lachal tendered his resignation, effective 26th July, to take up an appointment with the Antartic Division as Officer-in-Charge at Macquarie Island, 1986. Bob has been State Director for two years and his energy and hard work have had a marked impact on Victorian Rowing in that period. At the July General Committee Meeting his resignation was formally accepted and our President conveyed to Bob the thanks of the Association members and good wishes on his new appointment.

Consequent on these two happenings and over the next month, the Executive Committee will be giving urgent consideration as to how the two positions are to be filled or whether there are alternatives as to how the Association can be provided with an effective administration. Most likely by the time this report is printed, proposals will be before members.

Before going on to more detailed recording of the Association's activities for year 1984-85, a few words should be written on the criticism of Victorian Rowing and expressions of dissatisfaction of the situation as it exists at present. It has not been general, but has been enough to warrant attention. The comments cover a wide area ranging from those comparing Victorian apparent lack of progress with certain other States; not enough being done for sections of the Association and lack of professionalism, etc. The disturbing fact is, that practically without exception the criticism, complaints or comments which ever way one chooses to describe them, all come from within Association membership.

The Victorian Rowing Association comprises Clubs, Schools and their members. Delegates from Clubs and Schools comprise the Committee plus the officebearers who are in turn elected by the Committee delegates. Any comments, favourable or unfavourable from the membership, therefore reflect on that membership. The V.R.A. is not a separate body; it is a combination of all those Clubs, Schools and their members. In respect of administration most problems of the past season were due simply to lack of people willing and able to carry out all the necessary duties and tasks. We have to tackle the problems from within; they are not insurmountable and perhaps we are writing ourselves down by letting our problems overshadow our achievements.

Think about these facts:

Victoria's dominance in both Interstate and National Regattas in 1984 and 1985.

Victorian rowers comprising half the numbers in this year's overseas teams.

A financial position which is the envy of all other States.

At present we have some difficulties, but notwithstanding these it would appear we must be doing some things right.

#### OFFICIALS' PANEL

The season was again a busy one, with problems due to the falling number of licensed officials available for duty. The Panel officiated at 30 days of racing at some 14 courses, providing 368 licensed officials (around 114 less than 1983-84). This drop in numbers is especially worrying, despite the number on paper, and led to the continuance of one shift regattas and two shifts only at some very big regattas. The

result was that officials were required to be on duty for far longer than desirable. This situation, if continued, is cause for concern and likely to be self-defeating by the lowering of efficiency, and the likely effect on standards.

Officials of the Panel also played a prominent part in the inaugural Dragon Boat Races on the Yarra. Six officials arranged and supervised the racing at the two regattas.

During the season we welcomed Bill Davies, Jenny Kemp, Paul Knight, Rosemary McFarlane, Robin Murphy and Bruce Sarah as new officials to make a total of 66. However, the number of 5.6 regattas per official per season and 12.3 officials per regatta was too low as already indicated and must be a priority for consideration by the Panel and the Association for the coming season.

Our thanks are due to all Officials for their work during the season, especially those who cheerfully undertook long shifts at several regattas. Again we thank Jim Skidmore and Jim Harvey for their assistance with equipment and correspondence respectively and extend our appreciation to Mercantile and Yarra Yarra Clubs for the use of their facilities.

We are most grateful to our Panel, Reg McKay, Bob Duncan, Ralph Murphy, Ron Podbury and Bill Waterfield, for their efforts during the season, Bill Waterfield replaced Margaret Swan to whom we extend congratulations on the addition to her family.

#### L. E. Hanna (Panel Secretary)

Leigh Hanna resigned as Officials Panel Secretary during the year but continued the work of notifying officials of their regatta appointments until the final regatta. Leigh carried out the duties of Panel Secretary for several years with the utmost efficiency and we thank him for his work.

#### FINANCE

The financial position of the Association continues on a very sound basis and this year has again been substantially assisted by the continued sponsorship of Pilkington ACI Ltd. The financial assistance received has enabled the Association to provide services and amenities to members and our Interstate representatives which we would not otherwise have been able to do. Similarly there have been indirect benefits to Clubs by the use of sponsorship funds to absorb expenses which in other circumstances would have had to be passed on. There is a full detailed statement following covering the disposition of Pilkington ACI sponsorship and by careful study members can assess for themselves the extent and nature of the benefits referred to.

Normal recurring items of expenditure were contained within the levels of inflation, but there were large increases in Australian Rowing Council fees and insurance. The latter was caused by Public Liability cover and increased cover on equipment. Offsetting these were rises in fines and interest received. The loss on Championship and Selection Trials regattas was reduced from last year but was largely due to increased entries. Normally VRA regattas do more than break even but the loss this time was entirely due to the staging of the regatta at Carrum where facilities were Nil and had to be provided at an unavoidable cost.

The operating profit in comparison to recent years was substantially increased, but we should not be "carried away" with the result as there were several factors which contributed and were nonrecurring. First, the Interstate Regatta being in Victoria meant virtually no travelling expenses for our team. Next year we will be facing some \$16,000 or more and in the following year to Queensland, possibly \$30/35,000. The saving when the Australian Championships are held in Victoria has to be retained and offset against the expensive years to W.A., Qld. and Tas. Secondly, it will be noted that some \$11,000 of sponsorship funds, although committed, are not yet expended. Thirdly, some \$6,000 of the profit has been spent on equipment. Fourthly, as a result of considerable hard work, sponsorship assistance and more thorough planning we achieved a profit on the conduct of the Australian Championships, which we stage only once in every six years. In respect of the Interstate and National Regatta the result must reflect to a very large extent on the monetary assistance received from the sponsors, but due acknowledgement must be given to the huge amount of unpaid voluntary work contributed by Association members who were involved. The Executive Committee has decided the profit should not be taken into general revenue and subsequent expenditure but should be set aside for specific projects associated with future Interstate and National Regattas held in Victoria. As an example, assuming the Carrum course comes to fruition there may be facilities required which will not be provided, but essential to rowing. On the same lines Victoria does not have a 150th Anniversary every six years and next time there will be interest-bearing (cumulative) and will be available also to provide facilities at State Championships when and wherever an international course is established.

Finally a word on costs of professional administration of the Association, which expression has come into prominence recently. At present approximately 2500 members pay \$10 per annum each to meet V.R.A. costs and A.R.C. affiliation fees and levies. For every extra \$10,000 to meet costs of administration, the affiliation fee would have to be raised \$4 **UNLESS** the funds could be obtained from elsewhere. These figures should be born in mind when any consideration is being given to an increase in Expenditure.

Victoria has continued its active involvement in the functions of the Council through the medium of the following:

We extend our appreciation to these people and other officers of the Council for their service to Victorian and Australian Rowing. We thank also Mr. Alan Roaf of Queensland, recently appointed National Coaching Committee Convenor, for his valued assistance to our State Director in the conduct of coaching and other Seminars.

#### STATE DIRECTOR OF ROWING

1984-85 was a demanding period on the time of our State Director, Bob Lachal. Two particular involvements had an effect on the time available for direct promotion and assistance to Clubs. They were the Interstate and National Regattas and the launching of the Victorian Dragon Boats Association in Melbourne. Practically unaided, Bob organized the training of crews and the two Regattas held on the Yarra River in March and April. There was financial remuneration for the Association in both cases and this will flow on indirectly to members.

Following is a more detailed summary of Mr. Lachal's activities:

Visits to most country areas and Clubs with promotions at Dimboola, Horsham, Mildura, Wentworth, Hamilton, Footscray, Nagambie, Sale.

Assistance with organisation of National Regatta, in particular with tasks not possible to be undertaken by Organising Committee members in working hours.

Rowing display at Ballarat Gold Museum; an outstanding success.

Organisation of three Level 1 and 2 Coaching Seminars.

Assistance to Future Directions Committee Seminar.

Arrangement of sponsorships for Association from Pilkington ACI Ltd., Esso Australia Ltd., Carlton & United Breweries Ltd., APPM Ltd.

Frequent visits to existing rowing schools and schools interested in introducing rowing to curriculum. This involved use of the Association's video displays which have been substantially expanded.

Assistance to Clubs and Schools in obtaining of second-hand rowing equipment.

There were no doubt many other avenues of assistance rendered by our Director which would be known to the recipients. As noted earlier, Bob Lachal will have moved on to other fields by the time this report is printed and we wish him well on his venture into the Antartic in the coming months.

#### SPORT PROMOTION OFFICER

Following the Olympic Games and upon the return of the Olympic athletes to Australia, the Victorian State Government initiated a scheme for the engagement of unemployed Olympians as Sports Promotion Officers. Some sports gained full-time officers and rowing and canoeing were awarded a part-time officer each. The salaries of the promotion officers are paid by the State Government, but each comes under the administration of the relative sport. David Doyle commenced with the Association early in November, 1984. Coincidentally soon after, Victoria was awarded a Commonwealth Development Grant of \$6,666 and with additional funds already held we purchased six single training sculls complete with oars and trailer.

Working in close co-operation with the State Director, David has been of great assistance to Clubs and Schools in promoting rowing and sculling. The sculls have proved of immense value in introducing the sport to newcomers, not only in existing rowing areas.

Initially the Sports Promotion Officers scheme was for twelve months but the Committee has high hopes it will continue.

#### FUTURE DIRECTIONS OF VICTORIAN ROWING COMMITTEE

Throughout the year a committee comprising M. Bushby, D. Dudgeon, A. N. Geurin, D. Hadrian and R. C. Morell (Chairman) with assistance from the State Director, conducted an inquiry into whether it was considered that the direction of Victorian rowing was "on course" or should be varied. The investigation culminated in a 1½ day seminar conducted April 26/27 and which was attended by 70/80 members of the Association from Clubs and Schools. At the time of writing of this report, the official summary of the seminar and recommendations from the Committee have not been received; however, we take this opportunity to thank the Committee for their work.

The Executive Committee met on 15 occasions during the season and attendances were as follows:

Only those closely associated with this work would know the dedication, long hours and attention to the minutest detail that he gave to the organisation of a regatta programme. The Scotch Mercantile and Henley Regatta Committees would, no doubt, attest to his work also.

Thank you Bill for your work; you will be missed.
