# THE ONE HUNDRED AND TWELFTH ANNUAL REPORT AND STATEMENT OF ACCOUNTS OF THE VICTORIAN ROWING ASSOCIATION INC.

To the Members, Victorian Rowing Association, Ladies and Gentlemen.

Your Committee has pleasure in presenting the One Hundred and Twelfth Annual Report for the 1987-88 rowing season, together with the audited Balance Sheet and Statement of Accounts for the year ended 30th June, 1988.

The season was one of many highlights which were spread throughout the Association's activities from the development of rowing in Victoria at the grass-roots level to the achievements of Victorian rowers in elite competition. The continuing support of our sponsor Pilkington ACI Ltd. is greatly appreciated. All rowing clubs and schools in Victoria have benefited from the support together with all Association Regattas and Championships as well as other Regatta Committees. The support shown by the personnel of Pilkington ACI at regattas and at other Association events has been indicative of the close ties that have developed between the Association and our sponsor. The members of the State Team greatly appreciated the presence of Pilkington personnel at Penrith for the Australian Championships.

The season started with attention focused on the performance of Australian crews competing at the World Championships in Copenhagen, the World Junior Championships in Cologne and the Trans-Tasman Senior B series at Lake Karapiro, New Zealand. all crews represented Australia with distinction, even though the results were not as good as in 1986. Particular mention is made of the success of the Junior Team, with all crews making the final and one sculler winning the only medal for Australia.

At the Interstate level Victoria maintained its undisputed premier position with wins in the King's Cup, Penrith Cup and U.L.V.A. Trophy and second placings in four other Interstate events at the Australian Championships conducted at Penrith in New South Wales. Victorian Club and School crews also performed well in winning seventeen of the forty-seven National titles contested and we congratulate those winning crews and individuals.

The organisation and staging of the Australian Interstate and National Championships Regatta at Penrith was achieved despite the wet and muddy conditions during a lengthy period of wet weather and we congratulate the Organising Committee and the New South Wales Rowing Association on a job well done.

As this report is being prepared Victorian oarsmen and oarswomen are once again either competing in or preparing for overseas comptition in what has become a continuing cycle of regattas, selection trials, fundraising, training and overseas competition for many of our members. Australian crews will compete at the Olympic Games in Seoul, South Korea, the World Junior and Lightweight Championships in Milan, Italy, the International Under 23 Series in Adelaide, Australia, and the Junior Challenge against New Zealand on lake Karapiro, New Zealand. With 31 members in a total of over 90 in all teams, Victoria is still very much to the fore in Australian rowing and thanks go to all those who assisted with fundraising efforts to help meet the high costs of International competition by our members.

At the grass-roots level of rowing development in Victoria it is pleasing to record the affiliation of five new schools whose students are now participating in rowing. In addition, a number of other schools are taking an interest in rowing, either through existing clubs or the opening of a new rowing venue, and we look forward to further affiliations with the Association.

Over many years this Association has been indebted to the executive and members of the Victorian Oarsmen & Women's Association for their continued support of rowing in Victoria and again this season we are most grateful for the donation of two training sculls and a trailer to be used especially for the promotion of rowing throughout Victoria. All members are urged to further their interests in rowing through membership of the Oarsmen & Women's Association which is available at a very nominal fee.

The Association is again grateful for the continued support from the Department of Sport and Recreation in both financial assistance and guidance. The Department subsidises the salaries of the Administration Officer, the Marketing Officer and the Promotion Officer and provides funding towards the Association's development projects, such as the highly successful Junior Sculling Camp and the schools development in the South Eastern suburbs. Individual oarspersons are assisted by the Department through grants from the Sports Achievement Scheme, Sport Scholarship Scheme (The Squad) and the Country Travel Assistance Scheme, which are of great benefit to the recipients.

The MLC Group and the Department of Sport and Recreation are joint sponsors of the MLC Junior Sports Foundation and we thank them for their support of rowing through the scholarship granted to Jason Day of Bendigo Rowing Club.

Development of the National Water Sports Centre at Carrum has been slower than anticipated, after the previous Annual Report floodwaters got into the unfinished weir works rendering the course unusable for the season. However, repairs have been effected and the course is better than ever and ready for use in the coming season. The \$4.1 million project has been jointly funded by the State and Federal Governments and the Dandenong Valley Authority, project managers, have also contributed to the development. Discussions are currently being held to ascertain the most equitable means of financing the boatsheds and other onsite buildings which are the responsibility of the Sporting Association and other users.

It is pleasing to report the reformation of the Victorian Country Rowing Association for the purpose of promoting rowing in Victorian country areas. The Association conducted two successful regattas during the season, one on the Barwon River at Geelong and the Country Championships at Lake Wendouree, Ballarat, where competitors represented sixteen Clubs and Schools from country Victoria.

At the Victorian Championships Regatta and the National Selection Trial and Championships Regatta, both conducted at Lake Wendouree, Ballarat, the Association had the pleasure of entertaining Mrs. Foxcroft and Mr. Davis, representing our sponsors, Pilkington ACI, the Mayor and members of Ballarat City Council, Members of Parliament representing the Ballarat district and members of the Australian Rowing Council as an expression of your appreciation for their efforts towards the betterment of rowing.

The Australian Rowing Council Inc. has been busily engaged in the management of Australian rowing and we extend our thanks to Mr. R. N. McKay, Victorian delegate, Mr. N. F. Wilkinson, Honorary Treasurer, Mr. S. M. Gillett, National Director of Coaching Education, and the other members and officials of Council for their time and effort devoted to our sport. For his assistance to Victorian oarsmen and oarswomen we also extend our thanks to Mr. R. Batschi, National Director of Coaching.

It was with disappointment that during the season we recorded the loss by fire of the clubhouse previously used by the Essendon Ladies' Rowing Club together with a number of boats and equipment housed therein. On the brighter side it was pleasing to see the opening of the Hamilton Rowing Clubhouse and extensions to the Corio Bay Rowing Clubhouse.

As previewed in the previous Annual Report major changes have taken place in the Association's administrative structure. Mr. C. Wood of Beagle Research and Promotion was appointed Marketing/Sponsorship Officer and Mr. W. J. Waterfield was appointed as Administrative Officer. Due to a lack of nominations for the honorary position, the Association also found it necessary to make the position of Treasurer a salaried part-time position.

The position of Promotions Officer has also seen some personnel changes, starting the season with Mr. P. Antonie, who resigned to devote time to training and was replaced by Miss S. Ham. Following her decision to resume tertiary studies Mr. H. McGlashan was appointed. With the guidance of the Promotion Officer's sub-committee all three have been active in promoting our sport in clubs, schools and to the general public.

As a prerequisite for future Government funding and to provide guidelines for the development of rowing in Victoria, your Committee has prepared a five year Development Plan which will be presented to members early in the new season for their consideration and implementation.

Further to comments in previous Annual Reports the Association has received approval to conduct an International Regatta at Carrum as a warm-up to the 1990 World Rowing Championships to be held at Lake Barrington, Tasmania.

The general development of our fine sport and the conduct of this premier regatta is dependent on You, the members and the clubs, for You are the Association and we can't depend on Someone Else! So, when requests are made for people to serve on committees, assist at regattas or with the many other facets of Association activity, remember that the continuation of Victorian rowing is dependent on a great deal of hard work by many individuals at both the grassroots and elite levels of our sport.

### FINANCE

Analysis of the financial statements reveal that while Association funds have increased by a substantial amount (\$47,104), this has come about entirely from grants emanating from outside the Association itself viz: Commonwealth Development Grant, Metropolitan Rowing Committee, Victorian Oarsmen and Womens Association and our sponsor, Pilkington ACI Ltd. These sources have enabled us to provide many benefits for members; a detailed account of how our Sponsors' funds have been utilised, appears with the financial statements. The other funds have been utilised in the purchase of sculling equipment for use in promotion.

It will be noted that this year, Pilkington ACI Ltd. general sponsorship has not been included in the Income and Expenditure sector, but added directly to Accumulated Funds. The purpose is to show a more realistic perspective of Association financing with and without the benefit of substantial sponsorship. This was done on the strong recommendation of the V.R.A. Hon. Auditor and the Treasurer entirely concurred.

There were a number of variations, both up and down, in general income and expenditure, one of which was unexpected. This was the sharp increase in the loss on the State Championships and National Selection Trials Regattas. It prompts to again emphasise the comment of last year in that there is a need in some quarters for more caution to counter a tendency to relax supervision of expenditure. With so many unfulfilled needs, we cannot afford to be lax in any way.

Last year the Treasurer expressed confidence that there should be no need to increase affiliation fees in 1988/89 UNLESS extraordinary circumstances arose. Unfortunately they did arise in the form of a \$5 increase in A.R.C. affiliation fees, the effects of which will be felt in the second half of the coming season.

Another extra burden is the addition of the Women's Youth Four event at the Interstate Regatta. This however was self inflicted as the addition was initiated by Victoria and the extra cost of 7/8 more in the Interstate Team has to be found. The Interstate Fund as at present constituted is not able to meet the extra funds required. This year the cost was largely met from sponsorship funds and team members, but a more stable source has to be found for future years. This is currently being investigaged.

These two factors alone necessitated an increase in affiliation fees which was accepted at the June General Meeting.

Following assessment of the applications for the position your Committee appointed Mr. Bill Waterfield as Administration Officer. Mr. Waterfield took up the position with the experience of many years service as Honoarary Secretary of the Association.

During the season Mr. Waterfield has carried out the Secretarial functions of the Association and managed the Association's Olympic Park office, which provides a much appreciated day to day contact with members, various organisations and the general public.

Mr. Waterfield attended most regattas during the season in his dual capacity of Administration Officer and Officials' Panel Secretary and ably represented the Association on the National Water Sports Centre Steering Committee, the Herald-Manchester Unity Superswim Organising Committee and the Sports Federation of Victoria.

In conjunction with the Coaching Panel another successful Level One Coaching Seminar was conducted with good support from both clubs and schools resulting in 50 participants.

The Association is extremely grateful for the continued financial assistance and support from the Department of Sport and Recreation and the sponsorship received from Pilkington ACI which, with the levy imposed on all members, has provided the funds for both this and the following position.

### MARKETING/SPONSORSHIP OFFICER

Mr. Carl Wood of Beagle Research and Promotion was appointed to this new part-time position created by the aforementioned splitting of duties of the State Executive Director.

Mr. Wood, whose only previous contact with rowing was at Melbourne High School, has provided an outsider's viewpoint on matters usually taken for granted, which has been greatly appreciated by your Committee.

Mr. Wood has been active in further cementing the relationship between our sponsor Pilkington ACI and the Association and his efforts have been rewarded by the continuing support received from this Company.

His marketing ability produced the format for the off-water activities at the Pilkington ACI Selection Trial Regatta which contributed greatly to the success of the regatta and his skills ensured that the media adequately covered this and other Association events.

Your thanks are expressed to Mr. Wood for his efforts on behalf of Victorian rowing.

### SPORTS PROMOTION OFFICER

As mentioned earlier in this Report the person employed as Promotion Officer has varied during the season with Mr. Peter Antonie, Miss Sarah Ham and Mr. Hamish McGlashan being appointed for various periods due to changing circumstances.

The Association is indeed grateful to the Department of Sport and Recreation for the part-time salary subsidy again made available and their consideration and support during the various changes. Thanks are also expressed to our sponsor, Pilkington ACI Ltd., who have assisted with the funding of the various programmes.

A feature of the season was the inaugral Junior Sculling Camp conducted in January when 30 boys and 18 girls from all parts of the State received instruction and practical tuition in sculling. The three Promotion Officers, together with a number of other coaches, conducted the four-day camp on the Yarra River, which was voted by all participants as a huge success.

The schools promotion in the South-eastern suburbs has been hampered by delays with the Carrum course, however, progress is being made and four sculling boats are being used for promotion in the area.

Through generous donations and other monies being made available additional sculling boats have been obtained and the fleet has been of great assistance to the Promotion Officers in numerous promotions with clubs, schools and the general public throughout the State.

We take this opportunity to express our thanks to the Promotion Officers for their efforts on our behalf.

### OFFICIALS' PANEL

This season, with the support and participation of many officials, both long serving and newly licenced, the Panel were able to provide a complement of competent officials at all regattas, even if on occasions the numbers were a little sparse.

The Panel thanks these officials for their work during the season, especially those who cheerfully undertook long shifts at several regattas. Again we thank Jim Skidmore, Robin Murphy and Ron Richardson for their assistance with equipment and extend our appreciation to Mercantile Rowing Club for the use of their facilities.

With the development of rowing and the increase in both participation and the number of regattas being conducted it is essential that new officials are recruited. The Panel are ever ready to conduct tests for prospective officials and seeks the assistance of clubs and schools in this regard lest the standard of regattas decline.

The Association is most grateful to the members of the Panel, Reg McKay, Chairman, Bruce Adam, Bob Duncan, Ralph Murphy and Ron Podbury, for their efforts in maintaining our high standard of regattas during the season.
