#### THE ONE HUNDRED AND THIRTEENTH ANNUAL REPORT AND STATEMENT OF ACCOUNTS OF THE VICTORIAN ROWING ASSOCIATION INC.

To the Members, Victorian Rowing Association, Ladies and Gentlemen.

It is with pleasure that your Committee presents the One Hundred and Thirteenth Annual Report for the 1988-89 rowing season, together with the audited Balance Sheet and Statement of Accounts for the year ended 30th June, 1989.

The season could once again be described as one of many highlights which were distributed through most sectors of the Association's activities from the grass roots development of rowing in Victoria to medal winning performances by Victorians in National crews. The ongoing support from our sponsor Pilkington (Australia) Limited is much appreciated and sponsorship funds have been utilised in many facets of the Association's activities to the benefit of all Victorian clubs and schools as well as Association Championships and Regattas. It has also assisted members of the State Team who were pleased to have the presence and support of Mr. Don Davis of Pilkington at the Wellington Dam for the Australian Championships.

The season opened with our attention held by the performance of Victorian oarsmen and women at the Seoul Olympic Games in South Korea, the World Lightweight and Junior Championships in Milan, Italy and the Trans-Tasman Senior B Series held at West Lakes in South Australia. The Olympic results were good results, although no medals were achieved in the classiest Olympic field for many years, while the Lightweight and Junior Team returned with two Silver medals and a Bronze medal, including the best result ever by an Australian Junior Team. The Senior B team was totally dominant over New Zealand winning by 112 points to New Zealand's 74 points.

The staging of the Australian Interstate and National Championships on the newly developed course at Wellington Dam near Collie was a credit to the Organising Committee and the Amateur Rowing Association of Western Australia but unfortunately Cyclone Ned was the ultimate victor when it caused the abandonment of the Championships soon after the start of the National finals and before any Interstate events could be conducted. Your commisserations are extended to the Organising Committee and the Victorian oarspeople selected in State crews whose efforts were thwarted by the abrupt closure of the regatta. Members of the Victorian Eight gained some consolation later when they won the Interstate Eight-oared Challenge event held at Carrum.

On a more pleasant note, Sunday, October 30th, 1988, marked the official opening of the National Water Sports Centre at Carrum by the Minister for Sport and Recreation the Hon. Neil Trezise after ten years of planning, frustration, financial and construction problems. Participating in the rowing display before over 300 guests and dignitaries were students from St. Paul's School Woodleigh and Scotch College as well as 1988 Olympians Hamish McGlashan, Peter Antonie, Paul Reedy and Richard Powell. The Dandenong Valley Authority is commended for the successful completion of Stage One Development and while facilities off course for spectators and competitors to date leave something to be desired plans are already well underway for an improved starting facility, judges tower and boatsheds. Our thanks go to Centre Manager, Mrs. Margaret McLean, for her promotion of the Centre and assistance to rowing.

The support from the Department of Sport and Recreation was once again of immense benefit to the Association in both financial assistance and guidance and for this we are most grateful. Salary subsidies were received for the Administration Officer, the Marketing Officer and the Sports Promotion Officers in addition to funding towards the Association's development projects such as the most successful Youth Sculling Camp, the schools development in the South-east area and the coaching seminars. Grants are also provided for individual oarspersons from the Sports Achievement Scheme, the Quit Squad Sports Scholarship Scheme and the Country Travel Assistance Scheme which are all greatly appreciated by the recipients.

The Department of Sport and Recreation were also joint sponsors with the MLC Group for the scholarship awarded to Jacob Dingle of Melbourne University Boat Club and with the Commonwealth Bank of Australia for the funding assistance provided for the Sculling Development Camp held at Ballarat and we thank these companies for their support of rowing.

As this report is being written Victorian oarspeople in Australian crews are preparing for competition at the World Rowing Championships in Bled, Yugoslavia, the World Junior Championships in Szeged, Hungary, and the Trans-Tasman Senior B Series on Lake Ruitaniwha in New Zealand and we wish all team members every success. Victorians are still prominent in Australian rowing and thanks go to all those people who assisted with fundraising efforts to help meet the high cost of international competition by our members.

Members of the Australian Junior Team have recently tasted international success in convincingly winning the Trans-Tasman Junior Challenge held at Lake Barrington in Tasmania.

During the season there have been major changes in the office-bearers of the Australian Rowing Council Inc. following the resignation of the President, Mr. J. D. Coates, the appointment of the Secretary, Mr. J. F. Boultbee, to the position of FISA Secretary-General and an election for National Selectors, Mr. R. N. McKay has been elected as President and Miss M. E. Foster has been appointed Secretary. We thank all of these people together with Mr. N. F. Wilkinson, Treasurer, and the other members and officials of Council for their devotion to our sport. We also extend our thanks to Mr. R. Batschi for his assistance as National Director of Coaching during the past ten years.

Again during this season there have been changes in the people holding the position of Promotions Officer. To Messrs. H. McGlashan, P. Reedy and P. Baddeley, together with Mr. D. H. Boykett and numerous others who have assisted with the conduct of the Youth Sculling Camp, the sculling and rowing clinics and the schools promotion held at Carrum, we extend our thanks.

Congratulations are extended to Mr. J. L. Hardie who was appointed a Life Member of the Association in recognition of his many years service to the Association and rowing.

Due to a lack of any rowing activity a number of schools were deleted from the list of affiliated schools but this was compensated for by the affiliation of two new clubs and two additional schools during the season.

Thanks are expressed to the Ballarat Rowing Association for their cooperation in conducting additional championship events to complete the programme of championships following problems caused by very strong winds during the regattas at the National Water Sports Centre - Carrum.

During the season there were still far too many ineligible crews appearing at regattas which shows a lack of consideration for eligible crews who spend so much time and effort in training and competing and are then denied a result. As well as attracting monetary penalties these ineligible crews do nothing to promote our sport and reflect poorly on club administration. Remember, if you want your sport to be promoted and improved the matter is in your hands.

In 1990 Victoria will be conducting the Melbourne International Regatta at the National Water Sports Centre - Carrum on October 13th & 14th as a lead-up to the World Rowing Championships being held at Lake Barrington, Tasmania from October 28th to November 4th.

We look forward to these events because they will give all members of the Association the chance of seeing the best crews in the world in competition.

All members are urged to give their wholehearted support to the Organising Committee for the Melbourne International Regatta, who are already active with preparations, and assist them to make this Regatta a truly memorable event.

Disher Trust Fund, R. W. Thursfield Trust Fund, N. F. Wilkinson BEM Trust Fund, Family of the late M. S. Williams Trust Fund, Lodge Henley Trust Fund.

#### FINANCE

Association funds have again increased substantially, but it is prudent to again highlight that this is due to extraordinary items viz: Pilkington Australia Ltd sponsorship, the Department of Sport and Recreation permission to utilise a development grant for the purchase of promotional equipment, and the interest on the Carrum Reserve Fund. Eliminate these and the increased operating loss of \$16,444 is the result. Once the Carrum funds are expended the large interest component of recent years income will disappear. It is foreseen that this is most likely to happen in the coming financial year.

As long as operating costs continue to rise, we must be prepared to match these with rises in regular income items. To continue to rely on funds emanating from outside normal Association sources to cover operating expenditure in excess of income is shortsighted and could lead to a crisis if outside sources suddenly disappeared in a particular year.

A major cause of the poor operating result for the year was that the Interstate Championships in Western Australia are the most expensive of the five years when the Regatta is held outside Victoria. Notwithstanding this, next year in Tasmania will also be expensive and with no sign of inflation being curbed little relief can be expected. We were fortunate this year in being able to call upon sponsorship funds to meet the difficulty which could have existed had they not been available.

The finance sub-committee has proposed plans to restructure the Interstate Team financing and these are currently being examined with a view to amendments to the Interstate Fund rules before next December.

Another major item was the \$5000 provided for preliminary expenses for the 1990 International Regatta to be held at Carrum. Quite possibly this could have been listed as an extraordinary expenditure item, but was not done so; as yet no budget has been submitted by the Regatta Committee.

The Committee considered it necessary to propose increased affiliation fees and other charges for Season 1989/90. However the latter were not approved at the July 1989 General Meeting and it now remains to be seen what adjustments will have to be made to expenditure in the coming season.

#### ADMINISTRATION OFFICER

The continuing financial assistance and support from the Department of Sport and Recreation and the sponsorship received from Pilkington (Australia) Limited, for which the Association is extremely grateful, together with the levy imposed on all members has provided the funds for the Administration Officer, Mr. Bill Waterfield, to carry out the various secretarial duties of the Association and manage the Association's office.

The Olympic Park office has developed into a much appreciated point of contact and source of information for clubs, schools, oarspeople, prospective oarspeople, other rowing Associations, Government and other organisations, various media outlets and the general public on everything related to our sport.

In his dual capacity of Administration Officer and Official's Panel Secretary Mr. Waterfield has attended most regattas during the season and also ably represented the Association on the Herald-Manchester Unity Superswim Organising Committee and the Sports Federation of Victoria as well as at various official functions and meetings.

In conjunction with Mr. Martin Owen and the Coaching Panel and with good support from clubs and schools a successful Level Two Coaching Seminar was held at St. Kevin's College in July 1988 and a very successful Level One Coaching Seminar was held at Ballarat in November 1988, both with financial assistance from the Department of Sport and Recreation.

With an increasing workload, changes to this part-time position are to be considered in the new season.

#### MARKETING/SPONSORSHIP OFFICER

During the season Mr. Carl Wood of Beagle Research and Promotion has been actively engaged in servicing the sponsorship of Pilkington (Australia) Limited and bonding the relationship of the Association with this Company and his efforts have been rewarded with the continued involvement of the Company with Victorian rowing at all levels.

Among Mr. Wood's achievements have been the successful luncheon to officially launch the 1988/89 season and the official luncheon to mark the successful Pilkington Selection Regatta at Carrum.

In developing corporate and organisational strategies to enhance the future of the Association Mr. Wood was instrumental in preparing the five year Development Plan and the new sub-committee structure.

The Association is extremely grateful for the Pilkington (Australia) Limited sponsorship and the financial assistance from the Department of Sport and Recreation which has funded this position.

The formal agreement between Beagle Research and Promotion and your Association has been brought to a close and your thanks are expressed to Mr. Wood and his Company for their efforts which have continued our support from Pilkington (Australia) Limited and presented new avenues for the presentation and promotion of rowing.

#### SPORTS PROMOTION OFFICER

Again this season, due to illness and studies, there has been a changing face to our Sports Promotion Officer and we are extremely grateful to the Department of Sport and Recreation for their approval of a flexible approach to a changing situation. Thanks are also expressed to the Department for the part-time salary subsidy which made this position possible and for the funding of various programmes carried out by the Sports Promotion Officers.

During the season Mr. Hamish McGlashan, Mr. Paul Reedy and Mr. Paul Baddeley have been appointed as Sports Promotion Officers.

Another successful Youth Sculling Camp was conducted in December at the Power House and Wesley College Boatsheds when 31 girls and 9 boys from all parts of Victoria received instruction and practical tuition in sculling at the four day live-in camp. Promotion Officers Hamish McGlashan and Paul Reedy were ably assisted by a number of coaches and other assistants who combined to make the Camp such a great success.

An important programme this season has been the schools promotion in the South-eastern suburbs centred on the National Water Sports Centre at Carrum. In conjunction with the Centre Manager, Mrs McLean, the Promotion Officers, together with Mr. David Boykett and the assistance of numerous oarsmen, have introduced and developed the interest of some 700 students from nine Secondary Schools to rowing.

Other promotional activity at Carrum has been the Sculling Clinic in January conducted by Mr. David Boykett, Mr. Don Macmillan and others and the Rowing Clinic during the June school holidays by Mr. Paul Baddeley and others, both of which were well supported and successful.

In addition, the fleet of sculling boats have been widely used by clubs and schools for the promotion of rowing and a number of rowing promotions at schools and at Myer Melbourne have been arranged.

We take this opportunity to express our thanks to the Promotion Officers and all those who have assisted them for their efforts on our behalf.

#### OFFICIALS' PANEL

During the season the Panel were able to provide officials to operate at all 29 days of regatta racing, even if on occasions the numbers were a little thin, thanks to the support and participation of most officials for, no matter in what capacity they acted, all contributed to the successful conduct of regattas throughout Victoria.

New officials are always required to help replace those who have opted out of active regatta participation and the Panel extends a welcome to Messrs Mark Brown, John Fairbank and Chris Long, all of Yarra Yarra Rowing Club, who were successful in obtaining their licences during the season.

Once again, we thank Jim Skidmore and Ron Richardson for their assistance with equipment and Mercantile Rowing Club for the use of their facilities.

Our Chairman, Reg McKay, has resigned after five years in the position and we wish him well in his new position of President of the Australian Rowing Council, Special thanks are also expressed to the other members of the Panel, Bruce Adam, Bob Duncan, Ralph Murphy and Ron Podbury for their sterling service this season.
